BRIEF IN SUPPORT OF PLAINTIFFS’
EX-PARTE MOTION TO EXCEED PAGE LIMITATION

Plaintiffs rely on LR 7.1 (c)(3)(A) which provides, in pertinent part, that “A party seeking to file a longer brief may apply ex parte in writing setting forth the reasons.”

In the case sub judice, Defendants’ Motion for Summary Judgment raises complex legal issues. Defendants’ brief (Doc. No. 34) is twenty pages long, they attach exhibits totaling an additional 180 pages (Doc. Nos. 34-3 through 34-12), and they have filed seven more exhibits under seal. Defendants’ motion treats as simple what are in fact novel arguments in a highly specialized industry. Plaintiffs’ response will of necessity discuss the complex legislative history
