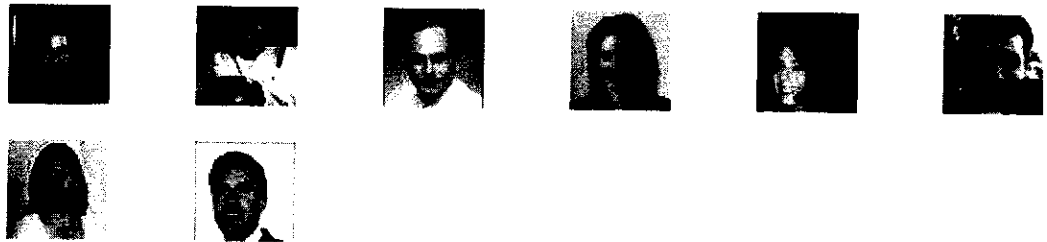

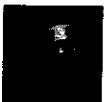

### 1. This Is a Contract Between You and RealSelf, Inc.
