Circumstance: Indecent exposure

Observations: Debra, library employee, stated that today around 1550 hours she was approached by Paul, witness, who stated that someone was in the computer lab masturbating. Debra went over to the computer lab and observed a W/M, later identified by his Michigan operator's license as Thomas Dangelo, slouched down in his chair with his right hand on the keyboard and left hand in his lap on his crotch. Debra stated she could see Thomas' left hand moving back and forth inside his pants as if he was masturbating, however couldn't see what he was viewing. Debra stated that per library policy they must send a computer message to Thomas advising him to stop what he's doing due to a complaint. Debra sent the message.

Paul stated that he was sitting next to Thomas for about an hour. Paul stated that for approximately 45 minutes he observed Thomas looking at "hard core porn web sites" while his pants were unzipped. Paul stated that Thomas had pulled his penis out, through his zipper, and began pumping his penis while moaning and groaning. Paul stated he left the computer lab and advised Debra of the situation. Debra contacted Ctpd. Officers located Thomas in the computer lab on the computer. Officers observed Thomas looking at no porn and couldn't find any web site history to show he was looking at porn. Thomas' pants were zipped upon making contact with him. Officers placed Thomas in handcuffs (s.d.I), searched, and placed under arrest for indecent exposure. Thomas was placed in back of patrol vehicle to be transported to Ctpd for booking procedures. Debra stated that she would not let anyone use Thomas' computer until the library's IT technician, Andy Nordin (Tx: _____), could examine it further. Debra stated Andy will be in Monday morning to examine the computer.

Action taken: Thomas was transported to Ctpd and held on \$500.00 cash bond.
