NOTICE OF COMPLAINT AND ARREST PURSUANT TO ADMIRALTY RULES

NOTICE IS GIVEN that Great Lakes Exploration Group LLC filed a Verified Amended Complaint on September __, 2004, in the U.S. District Court for the Western District of Michigan, Civil Action No. 1:04-CV-375, pursuant to Fed. R. Civ. Proc. Rule 9(h) and Supp. Rule C, against the Defendant Unidentified, Wrecked and Abandoned Sailing Vessel, her tackle, apparel, appurtenances, cargo, etc., located within a circle having a radius of 3.5 statute miles, whose center point is at coordinates 45° 32.8' North latitude and 86° 41.5' West longitude, praying that Plaintiff be declared the sole rightful owner and/or possessor of the Defendant

shipwreck or alternatively that Plaintiff be awarded a liberal salvage recovery with respect to the Defendant; and that Plaintiff be declared entitled to the sole and exclusive right to recover, control, possess, salvage and transact with the Defendant without interference by third persons or parties, and that all such interference be temporarily and permanently enjoined.

On _____, the United States District Court for the Western District of Michigan ordered that a warrant of arrest issue pursuant to Fed. R. Civ. Proc., Supp. Rule C, and that the U.S. Marshal for the Western District of Michigan arrest and take into custody such portions of the Defendant wrecked and abandoned sailing vessel, *etc.* as are within the district and further ordered that the Court has assumed jurisdiction over the Defendant Unidentified, Wrecked and Abandoned Sailing Vessel, her engines, tackle, apparel, appurtenances, cargo, *etc.*, located within a circle having a radius of 3.5 statute miles, whose center point is at coordinates 45° 32.8' North latitude and 86° 41.5' West longitude.

The Court further ordered, under penalty of default, that any person claiming any interest in the *in rem* Defendant shipwreck or any portion thereof must file with the Clerk of Court a verified claim within 10 days after process has been executed, and must file an answer within 20 days after the filing of the claim.
