- 17 1. FRCP Rule 38(a)(b): The right of trial by jury as declared by the Seventh
- 18 Amendment to the Constitution or as given by a statute of the United States shall
- 19 be preserved to the parties inviolate. (b) Any party may demand a trial by jury of
- 20 any issue triable of right by a jury by (1) serving upon the other parties a demand
- 21 therefor in writing at any time after the commencement of the action and not later
- 22 than 10 days after the service of the last pleading directed to such issue, and (2)
- 23 filing the demand as required by Rule 5(d). Such demand may be indorsed upon
- 24 a pleading of the party.
- 25 2. The Plaintiff requests a class action determination, jury trial demanded.

1 **WHEREFORE**, Plaintiff prays this Honorable Court GRANT Plaintiffs Demand For Jury  
2 Trial and radically discipline Defendant for deprivations of Plaintiffs Federally Secured  
3 and Protected Constitutional Rights.
