COMPLAINT and JURY DEMAND

There is no other civil action between these parties arising out of the same transaction or occurrence as alleged in this Complaint pending in this Court, nor has any such action been previously filed and dismissed or transferred after having been assigned to a judge

Now comes Michigan Insurance Company as Subrogee of Hajek Corporation and in support of its complaint states as follows:

- 1. Michigan Insurance Company is an insurance carrier licensed to do and doing business in the state of Michigan.
- 2. Hajek Corporation is a Michigan corporation doing business in the state of Michigan and was at all times relevant hereto insured under a policy of insurance issued by Michigan Insurance Company.

- 3. Taiwan Novelty Limited is a company doing business in the State of Michigan, whose corporation is located at 2nd Floor, No. 2 Ming Tsu East Road, 104 Taipei, Taiwan.
- 4. Huizhou Zhaoxin Technology Factory, is a company doing business in the State of Michigan, whose corporation is located at Qiaoxi District Sandong Town, Huizhou GD, China.
- 4. That the events which comprise the subject matter of this complaint occurred at 4589 Greenwood Rd. Petoskey, Michigan 49770.
- 5. That the amount at issue exceeds \$25,000 and venue is proper in this court.

COUNT I - FAILURE TO WARN HALLMARK

That Plaintiff hereby incorporates by reference the allegations contained in Paragraphs 1-5 above.

- 6. That prior November 6, 2008 defendant placed into the stream of commerce Jumbo snow globes with large cylinders acting as magnifiers.
- 7. That plaintiff's subrogor Hajek Corporation was a distributor of the Hallmark items.
- 8. That Hallmark failed to warn plaintiff's subrogor of the potential refractory hazards of the snow globes.
- 9. That as a result of the failure to warn Hajek Corporation stored the snow globes in an area subject to infiltration of sunlight, which resulted in the snow globe acting as a magnifying glass and igniting adjacent combustibles.
- 10. That the snow globes were subsequently recalled by the defendant due to the fire hazard which caused this fire (Exhibit 1).

11. That as a result of the fire, Michigan insurance company made payment to its insured in an amount in excess of \$75,000.

Wherefore Michigan Insurance asks that this honorable enter judgment in an amount deemed just and equitable.

COUNT II - NEGLIGENCE

That Plaintiff hereby incorporates by reference the allegations contained in Paragraphs 1-11 above.

- 12. That prior to November 6, 2008 defendants placed into the stream of commerce Jumbo Snow Globes for sale to the general public.
- 13. That the snow globes when exposed to sunlight acted as a magnifying glass.
- 14. That defendant Hallmark knew or should have known that thick glass globes could be a fire hazard if exposed to direct sunlight.
- 15. That Hallmark was negligent in placing the globes into the stream of commerce due to their propensity for staring fires, and by failing to test or inspect the globes for fire hazard given the known propensities for magnifying glass to concentrate light and start fires.
- 16. That as a result of the negligence of Hallmark plaintiff's subrogor Hajek Corporation was a distributor of the Hallmark items.
- 17. That Hallmark failed to warn plaintiff's subrogor of the potential refractory hazards of the snow globes.

Wherefore Michigan Insurance asks that this honorable enter judgment in an amount deemed just and equitable.

COUNT III - PRODUCT LIABILITY BREACH OF IMPLIED WARRANTY

That Plaintiff hereby incorporates by reference the allegations contained in Paragraphs 1-17 above.

- 18. That defendants Taiwan Novelty Limited and Huizhou Zhaoxin Technology Factory companies designed manufactured, sold, marketed, and or packaged for sale the snow globes described in counts I & II above.
- 19. That the snow globes were defective at the time they left possession of Taiwan Novelty Limited and Huizhou Zhaoxin Technology Factory.
- 20. That the snow globes were defective to the extent that they utilized thick curved glass subject to directing light and starting fires.
- 21. That as a result of the defective condition the snow globes started a fire at 4589 Greenwood Rd. Petoskey MI 49770.
- 22. That Taiwan Novelty Limited and Huizhou Zhaoxin Technology Factory failed to warn plaintiff's subrogor of the potential refractory hazards of the snow globes.
- 23. That as a result of the failure to warn Hajek Corporation stored the snow globes in an area subject to infiltration of sunlight, which resulted in the snow globe acting as a magnifying glass and igniting adjacent combustibles.
- 24. That the snow globes were subsequently recalled by defendant Halmark due to the fire hazard which caused this fire (Exhibit 1).
- 25. That as a result of the fire, Michigan insurance company made payment to its insured in an amount in excess of \$75,000.

Wherefore Michigan Insurance asks that this honorable enter judgment in an amount deemed just and equitable.

Hazard: When exposed to sunlight, the snow globes can act as a magnifying glass and ignite nearby combustible materials, posing a fire hazard.

Incidents/Injuries: Hallmark has received two reports of the snow globes igniting nearby materials. No injuries have been reported.

Description: This recall involves a Hallmark Jumbo Snow Globe in the shape of a snowman with model number 1XAG5093 and UPC code 795902066666. The snow globe measures 11 by 12 by 17 inches. The model number and the UPC code can be found on the back of the hangtag.

Sold at: Hallmark Gold Crown stores nationwide from October 2008 through November 2008 for about \$100.

Manufactured in: China

Remedy: Consumers should immediately remove the snow globe from exposure to sunlight and return it to any Hallmark Gold Crown store for a full refund.
