Frankly I am puzzled by your letter of yesterday's date. You repeatedly refer to withheld "tapes." We have withheld only one recording, the genesis of which we have explained to you and Mr. Weber several times. As I indicated in my letter of April 28, when I am back in the office I will contact you regarding our decision about whether we will agree to produce the recording or submitting it to Magistrate Mayeron for an *in camera* review barring any broader waiver of privilege. While I appreciate your diligence in researching and quoting directly from the depositions of Mr. and Mrs. LeMond, I am aware of their testimony, and your sixteenpage letter does not change our stance.
