1 **ORDER**

2 The Court has considered the motion of defendants 3M Company and 3M  
3 Innovative Properties Company for an order transferring this case to the U.S. District  
4 Court for the District of Minnesota pursuant to 28 U.S.C. § 1404(a), the facts and  
5 averments set forth in the supporting declarations and exhibits filed concurrently  
6 therewith, the accompanying Request For Judicial Notice and the pleadings and papers  
7 that are the subject thereof, the arguments of counsel, and all pleadings and papers  
8 filed in this action.

9 The Court hereby finds that, considering the significant relationship between  
10 this action and the earlier-filed patent infringement action pending in the District of  
11 Minnesota, *3M Company, et al. v. Avery Dennison Corp.*, Civil Action No. 10-cv-  
12 02630 MJD/FLN (D. Minn.), the interests of justice and judicial economy that would  
13 be advanced by transfer, and the convenience of the parties and likely witnesses, there  
14 is good cause to transfer this action to the District of Minnesota.

15 1. Defendants' Motion to Transfer Pursuant to 28 U.S.C. § 1404(a) is  
16 GRANTED. This action shall be transferred immediately to the U.S. District Court for  
17 the District of Minnesota.
