Please be advised that, assuming the National Football League ("NFL") and the National Football League Players Association ("Union") have not agreed upon terms for a collective bargaining agreement by 11:59 p.m. on March 11, 2011 (when the parties' current agreement expires), the NFL's member Clubs will institute a lockout of members of the Union's bargaining unit immediately thereafter.

In the event of a lockout, Clubs will be delivering letters to their players in the form attached hereto. Should you have any questions, please do not hesitate to contact me.

Dear [Player Name]:

This is to inform you that the [Club Name] ("Club") will institute a lockout of its players at 12:00 a.m. Eastern time on March 12, 2011.

During the lockout, the following will be in effect:

1. You may not enter any Club facility or the stadium, except for the purpose of attending a non-Club event or Club charitable event.
2. You will not receive any compensation from the Club.
3. The Club will not pay for or provide health insurance or other active-player benefits or services. You have already received separate communications regarding your option to pay for health benefits continuation under COBRA.
4. You will not be permitted to perform any services under your Player Contract or otherwise perform any duties for the Club. This includes, but is not limited to, any duties you would otherwise be performing at Club facilities, such as playing, practicing, working out, attending meetings, consulting with Club medical or training staff (except as provided below), and making promotional appearances for the Club.
5. Testing and treatment obligations under the Policy and Program for Substances of Abuse and Policy on Anabolic Steroids and Related Substances will cease.
6. If you need information from the Club's human resources department (such as copies of your tax information, child support correspondence, or to arrange collection of personal property you may have left on Club premises), please call [human resources representative's name and title] at [contact number].
7. Except for the human resources representative noted above, Club personnel (coaches, trainers and other non-player staff) will not communicate with you regarding football or any other Club or NFL business issues. This means that they will not communicate with you regarding any issues relating to your current or potential contract terms, or about collective bargaining negotiations between the NFL and the Union.

This will be the case whether you are currently under contract with the Club or not.

8. If you have an agent, the same procedures stated above concerning access to Club facilities and communications with the Club will apply to your agent.
9. The Club will not give you any further instructions or guidance as to workouts or training.
10. Except for injured players rehabilitating from football-related injuries, the Club will not provide, arrange or pay for facilities, equipment or other services relating to training or workouts. Injured players will receive a separate letter regarding their treatment and rehabilitation during a lockout. Clubs will not provide or pay for treatment for non-football related injuries or illnesses.
11. Club security and Player Development staff will not assist you with legal or other problems.
12. If you engage in any activities during the lockout, even training, you do so at your own risk. Any injury resulting from such activities will not be the responsibility or liability of the Club or the NFL. You are free to engage in alternate employment during the lockout, but you will not be protected by the Club or the NFL against injuries during such employment. Once a new labor agreement is reached between the NFL and the Union, you may be expected to report to the Club immediately. Therefore, you should structure any alternate employment so you can return to the Club promptly after a new labor agreement is reached.

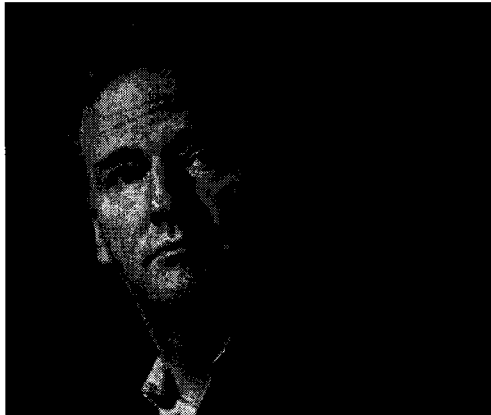

# NFL: Staggering financial losses would follow lockout

**NEW YORK** — NFL officials emphasized their resolve to reach a new labor agreement by early March in pointing to potentially staggering financial losses for both sides if a prolonged stalemate occurs.

"There are very powerful reasons for both sides to get an agreement by the beginning of March. We have our frustrations with the union and I would guess they have some

frustrations with us, but I think they know that, too," said Jeff Pash, general counsel to the NFL, during a 90-minute media briefing Thursday at league headquarters.

Pash added, "Hundreds of players stand to lose potentially hundreds of millions of dollars if we do not have an agreement by early March and are not able to proceed with the ordinary course of player transactions."

The collective bargaining agreement officially ends March 4. Owners, who are pushing to add two games to create an 18-game regular season and put limits on rookie salaries among other proposals, can opt to lock out players after that.

Based on contracts in effect as of Wednesday, the league says \$143.5 million is due to 74 players in March based on various bonuses and salary advances. If the NFL returns to a salary cap after an uncapped year and free agency is based on four seasons as it was before, the league says

there would be a record 495 free agents.

NFL Players Association executive director DeMaurice Smith has often accused ownership of being intent on a lockout. League representatives countered by estimating that revenue lost would total \$120 million in March, \$350 million by August and \$1 billion if no agreement can be reached in September.

The damage in lost revenue would escalate to more than \$400 million per week if the regular season arrives and no games are played, they said.

NFL treasurer Joe Sinclair said the potential for an interruption is already taking a toll. "Uncertainty affects our ability to generate revenues," he said. "We have already begun

to see the effect of that uncertainty."

League spokesman Greg Aiello said half of the 32 teams either have announced, or plan to announce, that they will not raise ticket prices for next season.

According to Pash, the league has ambitious plans moving forward that include investments in new stadiums in Los Angeles (in order to establish a team in that lucrative television market) and the Bay Area as well as Minnesota and Atlanta. But he contended that the current business model works against that, saying players received approximately 70% — or \$3.8 billion — of incremental revenues that totaled \$5.5 billion from 2006-09.

Although no new negotiating sessions are scheduled, Pash offered hope that a stoppage can be averted.

"In the face of considerable evidence to the contrary, I continue to be optimistic that we can accomplish this (by March 4)," he said. "I'm not saying we will, but that we can."

He also held out the possibility of having business proceed as usual beyond March 4 while talks are ongoing.

"If we're making progress and negotiations are proceeding toward a conclusion, you can stop the clock," he said,

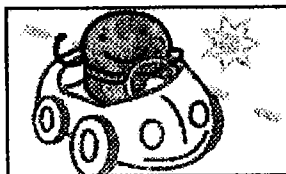

The NFL on Tuesday announced its schedule of nationally televised 2011 preseason games, starting with the Chicago Bears and St. Louis Rams in the Pro Football Hall of Fame Game on Sunday, Aug. 7 (NBC, 8 p.m. ET) in Canton, Ohio.

Two emerging teams -- the Kansas City Chiefs and Tampa Bay Buccaneers -- will be showcased in prime time Friday, Aug. 12 (FOX, 8 p.m. ET).

The Super Bowl champion Green Bay Packers will travel to Indianapolis on Friday, Aug. 26 (CBS, 8 p.m. ET) for their first nationally televised game since defeating the Pittsburgh Steelers in Super Bowl XLV.

Exact dates and times for games not shown on national TV will be announced later.

## Super Bowl champion Packers, Saints to kick off 2011 season

The NFL announced Tuesday that it will ring in the 2011 season with a meeting between the last two Super Bowl champions in the Sept. 8 Kickoff game.

The Green Bay Packers, who defeated the Pittsburgh Steelers in Super Bowl XLV, will play host to the New Orleans Saints, who topped the Indianapolis Colts in Super Bowl XLIV, at 8:30 p.m. ET at Lambeau Field in a nationally televised Thursday game on NBC.

The game pits two of the league's top-five passing offenses from the 2010 season. The third-ranked Saints and Drew Brees averaged 277.6 yards per game through the air, and the No. 5 Packers averaged 257.8 behind Aaron Rodgers.

It's the marquee matchup on a schedule that also features both New York teams and the Washington Redskins in action on the 10th anniversary of the terrorist attacks on the World Trade Center in Manhattan and the Pentagon in Arlington, Va., outside Washington, D.C.

The New York Giants will visit the Washington Redskins, and the New York Jets will play host to the Dallas Cowboys in the Sept. 11 games.

The NFL and its locked-out players are in mediation over a new labor agreement, and there is a risk the season might not begin on time – if at all – but Commissioner Roger Goodell said Tuesday that the league has "every intention of playing a full schedule."

"We're doing all we can to prepare for the 2011 season," Goodell said in Minneapolis, where he attended the third day of court-ordered mediation before U.S. Magistrate Judge Arthur Boylan. "We're announcing the schedule as usual, around this time of year, because we know that is an important point where fans start looking forward to the season, and I think there's every reason for them to do that. ... We've set the schedule up to play the full 16-game schedule, and that's certainly our intention, that's how we put the schedule together, and we certainly are working towards that."

The first Sunday features several high-profile games, including Indianapolis at Houston and Atlanta at Chicago. But much of the national focus will be on Washington and New York, the cities most affected by the terrorist attacks of Sept. 11, 2001.

"That stadium is going to be full of emotion, not only the people from the area, but in the entire country," said Jets coach Rex Ryan, who will match wits with his twin brother, Cowboys defensive coordinator Rob Ryan. "The fact that it's the 10th anniversary of 9/11, that's where the focus should be, not me playing against my brother."

The Redskins and Giants kick off at 4:15 p.m. ET, with the Jets and Cowboys at 8:20 p.m. ET.

"For nearly 10 years, we have felt an obligation to use our platform to make sure none of us ever forget the tragedy and heartbreak and courage and heroism of Sept. 11," Giants spokesman Pat Hanlon said. "That responsibility becomes even greater."

The Pittsburgh Steelers also will play on Sept. 11, visiting the Baltimore Ravens. Pittsburgh is just 80 miles from the site near Shanksville, Pa., where Flight 93 crashed on Sept. 11, 2011.

New England travels to Miami, and Oakland visits Denver on the opening Monday night.

The final Sunday of the regular season falls on New Year's Day, when all 16 scheduled games are between division rivals, enhancing the potential for playoff ramifications.

The regular season covers 17 weeks, with the opening round of the playoffs scheduled for Jan. 7-8, 2012, and the Super Bowl on Feb. 5, 2012, in Indianapolis.

The NFL has expressed a desire to stretch the season to 18 games, one of the sticking points in the contentious fight between owners and players over a new labor agreement.

In its statement announcing next season's schedule, the NFL didn't provide contingencies should negotiations on a new collective bargaining agreement stretch into the fall.

"I'm confident we will have (a) season," Rex Ryan said Tuesday night. "We're going to be ready to play. Whenever they say, 'OK, we're going back to work,' we'll be ready to play."

Among other schedule highlights, the Tampa Bay Buccaneers will face the Chicago Bears at Wembley Stadium on Oct. 23, one of two games outside the United States and the fifth consecutive year the NFL has played a regular-season game in suburban London.

The Bucs lost to the New England Patriots at Wembley in 2009; the Bears will be marking the 25th anniversary of their preseason game against the Cowboys in England.

The Buffalo Bills will play a game in Canada for the fourth consecutive season, playing host to the Redskins on Oct. 30 at Rogers Centre in Toronto. The Bills have a deal with Rogers Communications through 2012 to play five regular-season games in Canada's largest city.

The Thanksgiving Day games are Packers at Detroit, Miami at Dallas and San Francisco at Baltimore, with new 49ers coach Jim Harbaugh facing Ravens coach John Harbaugh in the first meeting between sibling head coaches in NFL history.

The Packers play the Bears in the only Christmas Day game. There are 13 games scheduled for Dec. 24, including the Giants against the Jets.

The NFL will again use "flexible scheduling" for Weeks 10 through 15 and the final week of the regular season, allowing the league to move the start times for select games.

## Exclusive: Roger Goodell criticizes NFL players' legal strategy

With another round of mediation talks this week failing to result in a new labor deal and a federal judge poised to rule within days on whether to lift the NFL's lockout, Commissioner Roger Goodell on Friday blasted the legal strategy pursued by players as an impediment to striking a collective bargaining agreement.

Goodell addressed that topic during a wide-ranging interview with USA TODAY, expressing frustration with the uncertainty of the labor battle and concern about the impact on league economics and business partnerships.

Judge Susan Nelson, who ordered the two sides to engage in mediation talks that ended Thursday, could issue a ruling early next week on the lockout -- while the league in limbo prepares to stage its signature offseason event, the three-day NFL Draft that begins on Thursday night in New York.

"I don't think litigation is going to resolve this matter," Goodell told USA TODAY. "It's going to be resolved through negotiations and a broader collective bargaining agreement at the end of the day.

"I think it's a positive whenever you're negotiating, but clearly the litigation strategy that the union is pursuing is delaying some serious negotiations that really are going to lead to a collective bargaining agreement. That part of it is frustrating. I think valuable time is escaping us, that's putting financial risk and other risk in play. That's unfortunate for, most importantly, our fans, but also for our players and clubs."

Goodell wouldn't speculate on Judge Nelson's potential ruling on the case of Brady et al v. NFL, and how the league might respond. If the ruling favors players, the NFL is expected to appeal to the Eighth Circuit Court of Appeals and seek to have the lockout remain in force until the appeal is ruled upon.

"You have to wait and see what the ruling is before you start adjusting to a lot of hypotheticals," Goodell said. "Obviously, we recognized that they were going to pursue this litigation strategy. We were prepared for that. But again, it still needs to come back to negotiation."

The upcoming NFL Draft, which was included in the collective bargaining agreement that expired in March, won't be directly affected by the ruling.

Yet the legality of future drafts is among targets in possible antitrust action against the league. During the April 6 hearing, Nelson asked attorneys from both sides to offer visions of how the NFL would operate -- absent a CBA -- if she lifted the lockout.

Goodell wasn't in the courtroom on April 6, but undoubtedly senses the threat of a radical change to the NFL's system.

"I think when you get back and look at this, I think what's being pursued by the union attorneys is a completely different vision for the NFL than what I have," Goodell said.

"They're challenging fundamental aspects that have made the league successful and popular with the fans. They're going after the draft, as an example, pursuing the draft as illegal. They're pursuing free agency restrictions as illegal. They're pursuing aspects of the salary cap as illegal. That's what they're saying. We don't believe that. It's been negotiated. We think they've been good for the players, the clubs and, most importantly, the fans. It's what's created a successful product. So the union attorneys are attacking everything that we think has made the league successful."

Among other topics Goodell addressed:

- **On whether he's advised clubs about the prospect of a rookie wage scale for this year's draft crop:** "We haven't advised them of anything. I think they're approaching the draft as they normally do. They're obviously aware of the proposals we've made."
- **On contingencies built into the NFL schedule that was released this week to account for a prolonged work stoppage:** "We recognize the uncertainty of the labor situation, but we're planning to play a full 16-game regular season and playoffs. Anytime there's uncertainty for planning events, not only the logistics, but also for business partners, it does have an impact. That's why we think that the longer it goes, it's bad for players, the clubs, our partners, and the fans. That's why we need to get this resolved sooner, rather than later."
- **On how the lockout is affecting business relationships:** "There's no question it's starting to damage the planning and promotion of the season. It's going to have a financial impact that affects the clubs and the players."
- **On former New York Giants receiver Amani Toomer comparing Goodell to the secret police of the Nazi:** "This is a labor dispute. There are negotiations going on. I don't get myself caught up in the rhetoric of any personal comments that are made. The best thing that can be done is we get back to negotiating, and we resolve this in a fair manner." (Toomer later apologized for the remark.)
- **On why he called Cincinnati Bengals receiver Chad Ochocinco:** "He tweeted me out. He asked me to call him. I talk to players all the time."
