Our records indicate that you are attorney of record for the above mentioned case. However, we have no record of your admission to the United States District Court for the Southern District of Mississippi in this particular case. One appearance before a district judge or magistrate would allow you to be admitted to both the Southern and Northern Districts. However, to accomplish this, we would need a duplicate set of all the admission documents (including the oath of admission card). The admission fee is \$160.00 per district; if you want to be admitted to both the Southern and Northern Districts of Mississippi, you would need to provide two separate checks. We would receipt the fee for the Southern District and forward the other payment (along with the oath and supporting documentation) to the Northern District for processing.
