- 3. Whether drafting a blank legal document constitutes the practice of law or the unauthorized practice of law under Missouri law.
- 4. Whether "scrivening" or filling in blanks in a blank legal form with information provided by another person constitutes the practice of law or the unauthorized practice of law under Missouri law.
- 5. Whether causing software to auto-populate or fill in blanks in a blank legal form with information provided by another person constitutes the practice of law or the unauthorized practice of law under Missouri law.
- 6. Whether creating software that fills in blanks in blank legal forms with information provided by another person constitutes the practice of law or the unauthorized practice of law under Missouri law.
- 7. Whether proofreading of data files and other documents for consistency, spelling, grammar, and formatting constitutes the practice of law or the unauthorized practice of law under Missouri law.
- 8. Whether fees paid for registered agent services, living will alert wallet cards, corporate minutes, or corporate kits are properly included in damages in the case.
- 9. Whether fees paid for patent and trademark search and monitoring services are properly included in damages in the case.
- 10. Whether claims made on a theory of money had and received are subject to prejudgment interest accruing from before the filing of the petition when no demand was made prior to the filing of the petition.
- 11. If the Court or jury concludes that LegalZoom's actions are the unauthorized practice of law, what limited modifications are necessary to narrowly tailor an injunction to comply with § 407.010 RSMo.
