Dear City of Hamilton, Montana Attorney Bell,

J am in receipt of your August 20, 2010 letter (attached as Beil 8-20-10.pdf),

Your understanding of "criminal Justice information" is incorrect. The Montana Supreme Court found that the only ilmitation to releasing criminal justice information was a violation of privacy. It is found in

Bozeman Daily Chronicle v. Police Dept. 260 Mont. 225 1993, and Alistate Ins. Co. v. City of Billings 780 P. 2d 186 1989 (Montana Supreme Court cases):

In Alistate at 188: "Accordingly one is "authorized by law" to receive criminal justice information by the right to know provision of the Constitution. The only limitation on the right to receive the information is the constitutional right to privacy."

Therefore, I am waiving my right to privacy, and request information on case 29CR-2579, and the case of Officer Brad Weston interviewing me about my employer outside of the Ravailli County Administration building, and the employment being lost due to intimidation of my former employer by Officer Brad Weston.

I suggest you contact Regina Plettenbarg, Ravail Clerk and Recorder due to her office cailing the Police as I was taking pictures outside the building (obviously this was as much of a crime as sitting on public property, or taiking to a librarian). You are correct on the time being incorrect. I started working for that employer at the end of 2008. It was probably the spring of 2009. Not only was my right to a recall petition (my business at the County Building) not allowed as protected in the 1st Amendment to the constitution, but a 4th Amendment attempt and threat of seizure was attempted by Weston that day. Lets throw in an equal protection charge (amendment 14 US Constitution) just to make sure we did.

By the way, who do you work for and what is your social security number? [this was the querry of Hamilton's finest, HPD Brad Weston outside the administration building]. Who is going to hold you accountable for the FELONY of seeking a NCIC report on a non-crime in November 2009? [dont worry the FBI has the exact time and date of your querry]

I misplaced your second correspondence with respect to information, please resend this information.

The criminal charge for speaking to a librarian were on November 10, 2009 which is nearly 11 months ago. The 6th Amendment US Constitution has been violated. Oaths by yourself, and Mr. Com to the State and Federal Constitutions don't seem to mean much. Probable cause isn't needed in Hamilton Montana by either you or the county attorney Mr. George Com. I think the "wide latitude" [former US Atty Wettering, former Assistant Attorney General Seeley] of your and Com's job status might change soon.

209CR-2579 report-there is no fax number or email listing to the RCAO. I refuse to work with those employees who misrepresented Angela Wetzsteon's name for 3 years, and prosecuted me outside of my rights to speedy trial as a unsupervised law student (ie, a criminal act). This is how my FEMA career was lost on AUGUST 8, 2007 (when I was deployed as a federal officer).
