**NOTICE OF VIOLATION

Comes now Plaintiff with notice of deprivation of Plaintiff 4<sup>th</sup> Amendment right by Honorable US District Court for Montana in order dated 13 December 2011 with TR. # 189 in aforementioned.

US District court allowed a government subdivision, Defendant City of Hamilton access to search, seize Plaintiff confidential and protected documents, unreasonable in aforementioned. Well established, controlling authority, federal statute indicate actions of District Court depriving Plaintiff established right 4<sup>th</sup> Amendment US Constitution *US v. Miller 425 US at 442 (1976)*.

This court has blamed release of confidential information on Plaintiff for filing this action to redress injuries, deprivation within order (TR. #189) implying Plaintiff invited rights deprivation. Court has no respect for US Constitution, statute, makes no effort to protect Plaintiff established rights in 42 USC§ 1983.
