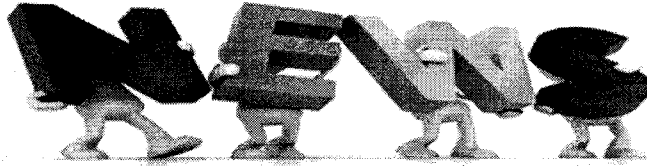

The Michael Spreadbury Find My Threat Story - Montana Probation Officers - Montana Corruption - Montana Law Enforcement

As promised, the FIND MY THREAT game has arrived.

On November 4, 2009 Michael Spreadbury approached a librarian and asked for help in public. The most intense evil, corruption, and hatred on the planet is incorporated in Hamilton Montana, and throughout the state of Montana which ranks 48 in the lower 48 for Justice (we have no justice--see what we did about it).

A county deputy prosecutor was promoted to work for Steve Bullock, Montana Attorney General in Helena assigned as "special Ravalli County prosecutor" in the case for Ravalli County Attorney George Corn.

A witness, Gavin Ricklefs "recognized" Michael Spreadbury although they never met.

The Librarian swore in court Nov. 20, 2009 that she did not remember anything Spreadbury said to her Nov. 4, 2009 outside the Bitterroot Public Library (witnessed).

[A credible threat must be communicated to reach the level of Felony Intimidation MCA 45-5-203]

The librarian also swore to Hamilton City Judge Michael Reardon that she went to the Hamilton Montana Police by herself--the Hamilton Montana Police report says differently. Reardon made opinion that Spreadbury did not violate any court restrictions at hearing November 20, 2009; in the hearing City Attorney Bell represented the Librarian, in violation of his official duties, known as Official Misconduct MCA 45-7-401 a misdemeanor in Montana.

The Librarian, and library are now being protected by a law firm [Boone Karlberg PC of Missoula, Montana] using fraudulent public funds [public fraud is the #1 CRIMINAL priority of the Federal Bureau of investigation (FBI)]: <http://www.fbi.gov/about-us/investigate>.

Affidavit of MICHAEL E. SPREADBURY

COMES NOW, MICHAEL E. SPREADBURY who, being duly sworn, makes the following affidavit as follows:

1. I am the Defendant in the aforementioned action in the 21st Judicial District of Montana.
 2. On August 20, 2009 I assembled on public property, 306 State St. Hamilton, MT.
 3. Assistant Library Director Roddy did not witness this constitutionally protected act.
 4. Ms. Nansu Roddy did not testify at trial as witness for criminal trespass trial on or around February 18, 2010 in Cause No. CR-2009-168 in Hamilton Municipal Court.
 5. I freely spoke to Ms. Nansu Roddy on November 4, 2009 without violating court restrictions to CR-2009-168, or issuing any threat to Ms. Roddy.
 6. No communicated, or implied threat is contained within a Hamilton Police Report, although false, defamatory, unprivileged information is contained in #209CR0002579.
 7. No supervisor signature is on report from HPD patrolman Weston for #209CR0002579.
 8. No probable cause exists to charge Felony Intimidation MCA 45-5-203.
 9. Peaceful assembly, Free speech constitutional protections prohibit enforcement of any law which "abridge" my 1st Amendment rights; contained in 14th Amendment to the US Constitution, Article II Sections 6,7 of the Constitution of the State of Montana.
 10. Charge of intimidation has no probable cause, and violates my state, federal rights herein.

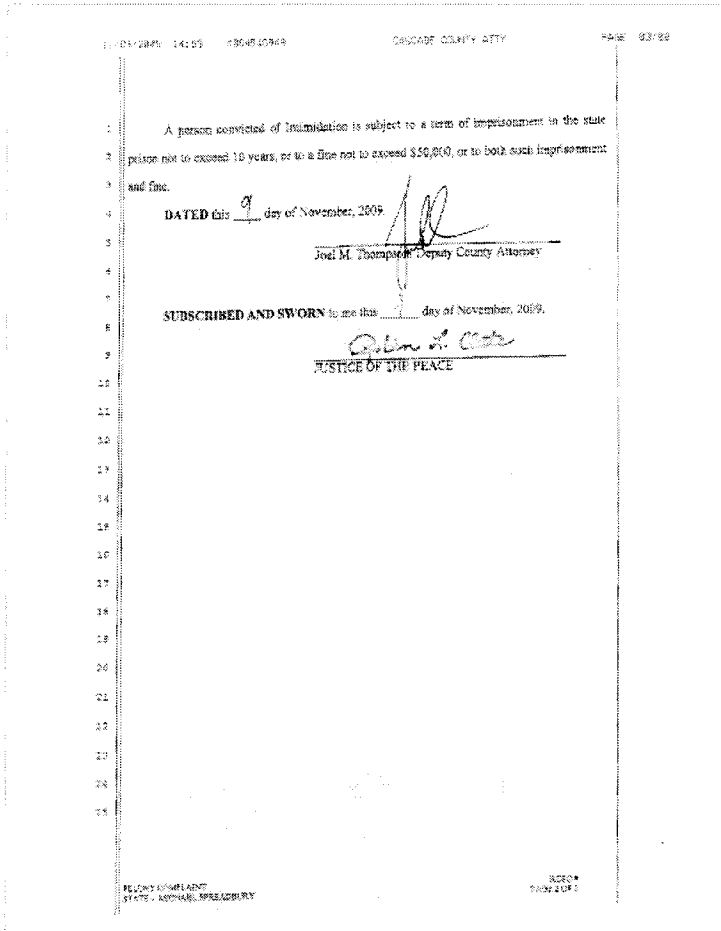

21 **CHARGE 1:**
 22 INTIMIDATION, a Felony, in violation of M.C.A. § 45-5-205 (2007). On or about
 23 November 4, 2009, the Defendant, with the purpose to cause Nansu Roddy to perform or to
 24 omit the performance of her acts as a witness to a prior criminal offense committed by the
 25 Defendant, communicated to Roddy a threat of physical harm to Roddy. The threat was

Joel Thompson was promoted by Montana Attorney General Bullock for prosecuting someone without probable cause, and in violation of their US, Montana Constitutional rights. Notice also on the page above that \$50,000 bail [excessive] was requested by George Corn Ravalli County Attorney through the special prosecutor Joel Thompson. This violates Spreadbury's 8th Amendment right to reasonable bail, the cause of the 2005 suicides in Ravalli County. The next pages are the NON-REVIEWED police reports from Hamilton Montana PD. Again we kept the officer's name off the report to keep Judge Haynes 21st Montana District Judge happy. The librarian was not a witness to peaceful assembly, protected right in 1st Amendment US Constitution. Spreadbury was asking for help to drop the charge, because it is not a crime to sit on public property peacefully in America. By the way, it is also not a threat to ask for anyone's help without threat in America [free speech].

The librarian told Michael Spreadbury "...she knew how to help him" after they spoke Nov. 4, 2009.

The free speech issue is pending on appeal at the 48th ranked Supreme Court in the continental United States: Helena Montana.

ON NOVEMBER 04, 2009 AT APPROXIMATELY 1235 HOURS, HAMILTON POLICE CLERK PAM LEMON ASKED ME TO SPEAK WITH NANSU RODDY IN THE HAMILTON POLICE DEPARTMENT LOBBY IN REGARDS TO MICHAEL SPREADBURY THREATENING RODDY AT THE BITTERROOT PUBLIC LIBRARY. IT SHOULD BE NOTED THAT WHEN I FIRST MADE CONTACT WITH RODDY, I NOTED THAT SHE APPEARED VISIBLY SHAKEN. RODDY STARTED CRYING DURING MY INTERVIEW WITH HER.

AT APPROXIMATELY 1237 HOURS, I MADE CONTACT WITH RODDY AND SHE WAS ACCOMPANIED BY HAMILTON CITY PLANNER DENNIS STRANGER IN THE HAMILTON POLICE DEPARTMENT LOBBY. I BRIEFLY SPOKE WITH STRANGER. STRANGER TOLD ME THAT HE WAS AWARE OF THE INCIDENT BETWEEN RODDY AND SPREADBURY BUT DID NOT ACTUALLY WITNESS THE INCIDENT. STRANGER SAID RODDY APPEARED VISIBLY SHAKEN AND EMOTIONALLY UPSET.

RODDY TOLD ME THAT SHE IS AN EMPLOYEE AT THE BITTERROOT PUBLIC LIBRARY. RODDY EXITED THE BITTERROOT PUBLIC LIBRARY VIA THE FRONT DOOR ON NOVEMBER 04, 2009 AT APPROXIMATELY 1155 HOURS. RODDY WAS WALKING TOWARDS HER VEHICLE THAT WAS PARKED ON THE SOUTH SIDE OF STATE STREET. RODDY STATED THERE WAS AN OPEN PARKING SPACE IN FRONT OF THE LIBRARY ON STATE STREET. AS RODDY WAS ABOUT TO WALK THROUGH THE OPEN PARKING SPACE, MR. MICHAEL SPREADBURY PULLED INTO THE OPEN PARKING SPACE. RODDY TOLD ME THAT SPREADBURY WAS DRIVING HIS PICK-UP TRUCK. RODDY TOLD ME THAT SHE RECOGNIZED SPREADBURY AS THE MALE OF THE IN THE TRUCK DUE TO THEIR PRIOR MEETING AT THE BITTERROOT PUBLIC LIBRARY.

SPREADBURY OPENED HIS TRUCK DOOR AND SAID TO RODDY "YOU NEED TO DO SOMETHING ABOUT WHAT IS HAPPENING TO ME." RODDY REPLIED TO SPREADBURY YOU KNOW THAT I CANT DO ANYTHING ABOUT WHAT IS HAPPENING TO YOU. RODDY FURTHER TOLD SPREADBURY THAT SHE WAS NOT IN A POSITION TO HELP HIM. RODDY STATED SHE TRIED TO EXPLAIN TO SPREADBURY THAT SHE WAS KIND TO HIM IN THEIR PAST MEETING AT THE LIBRARY. SPREADBURY STATED THAT THESE PEOPLE HAVE BROKEN HIM. ACCORDING TO RODDY, AS THE CONVERSATION WENT ON SPREADBURY BECAME MORE AND MORE AGITATED. RODDY EXPLAINED THAT SPREADBURY'S VOICE KEPT GETTING MORE ELEVATED. RODDY STATED THAT SPREADBURY FINALLY SAID TO HER "YOU NEED TO GO TO KEN BELL AND TELL HIM TO CLOSE THIS CASE." RODDY TOLD SPREADBURY THAT SHE COULD NOT DO THIS. RODDY TOLD ME THAT SPREADBURY REPEATED THE QUOTE SEVERAL MORE TIMES.

ABOUT HER GOING TO KEN BELL'S OFFICE TO GET HIS CASE CLOSED. RODDY TOLD ME SHE HAD TO DISTANCE HERSELF FROM SPREADBURY. RODDY EXPLAINED TO ME SEVERAL TIMES THAT SHE FEEL THREATENED BY SPREADBURY.

RODDY STATED AND DEMONSTRATED TO ME THAT SPREADBURY RAISED AND PUMPED HIS FIST IN THE AIR AND WHILE SHE WAS STANDING THERE TALKING TO SPREADBURY. RODDY EXPLAINED THAT SPREADBURY WAS APPROXIMATELY THREE TO FIVE FEET AWAY WHEN HE WAS PUMPING HIS FIST AT HER. RODDY THEN RAN TO HER VEHICLE AND SPREADBURY DEPARTED IN HIS VEHICLE. RODDY EXPLAINED WHEN SHE CROSSED THE STREET TO HER VEHICLE HER SIDE STEPPED ACROSS THE ROADWAY SO SHE COULD KEEP AN EYE ON SPREADBURY. *LIE #4*

RODDY STATED THAT SHE WAS LOOKING AROUND FOR A WITNESS TO THIS EVENT. RODDY STATED THAT GAVEN RICKLEFS, WHO WORKS AT BITTERROOT LAND TRUST, WITNESSED THE EVENT. IT SHOULD BE NOTED THAT BITTERROOT LAND TRUST IS LOCATED DIRECTLY ACROSS THE STREET FROM THE BITTERROOT PUBLIC LIBRARY. RICKLEFS EXITED HIS OFFICE AND ASKED RODDY IF EVERYTHING WAS OKAY. RICKLEFS TOLD RODDY THAT HE WITNESSED EVERYTHING BUT DID NOT HEAR WHAT WAS BEING SAID BETWEEN SPREADBURY AND RODDY. *Lie #6*

RODDY EXPLAINED SPREADBURY ONLY LIVES APPROXIMATELY TWO BLOCKS FROM HER AND SHE LIVES BY HERSELF. RODDY TOLD ME SHE FEELS VERY VULNERABLE DUE TO SPREADBURY BEING SO CLOSE. RODDY TOLD ME THAT SPREADBURY WAS ADVISED TO HAVE NO CONTACT WITH LIBRARY EMPLOYEES. RODDY EXPLAINED TO ME THE REASON SHE KNEW SPREADBURY WAS TO HAVE NO CONTACT WITH LIBRARY EMPLOYEES WAS DUE TO HIM BEING CHARGED CRIMINALLY AND BY THE JUDGES ORDERS. *Lie #7*

I ADVISED RODDY THAT SHE SHOULD GO TO HAMILTON CITY COURT AND ATTEMPT TO OBTAIN A RESTRAINING ORDER. *to bring to court*

I FURTHER ADVISED RODDY THAT I WOULD TYPE A REPORT ON THIS INCIDENT AND IT WOULD BE ON FILE AT THE HAMILTON POLICE DEPARTMENT. I FURTHER TOLD RODDY THAT I WOULD BE SENDING THIS CASE TO THE COUNTY ATTORNEY'S OFFICE FOR REVIEW FOR CHARGES. *to review management*

I MADE CONTACT WITH RICKLEFS AND ADVISED HIM OF THE REASON FOR THE CONTACT. RICKLEFS STATED HE WAS SITTING IN HIS OFFICE DOING SOME COMPUTER WORK WHEN HE WATCHED RODDY EXIT THE LIBRARY. IT SHOULD BE NOTED THAT RICKLEFS OFFICE FACES THE BITTERROOT PUBLIC LIBRARY. RICKLEFS STATED HE WATCHED A DARK BLUE CHEVY TRUCK PULL INTO THE OPEN PARKING SPACE. RICKLEFS STATED HE DIDNT KNOW WHO WAS IN THE TRUCK UNTIL HE FINALLY RECOGNIZED THE DRIVER AS SPREADBURY. RICKLEFS STATED HE COULD NOT HEAR WHAT WAS BEING SAID BETWEEN RODDY AND SPREADBURY. RICKLEFS TOLD ME THAT SPREADBURY WAS LEANING OUTSIDE OF HIS TRUCK AS HE WAS TRYING TO COMMUNICATE WITH RODDY. RICKLEFS STATED HE COULD TELL THE CONVERSATION WAS BECOMING MORE HEATED DUE TO THE BODY LANGUAGE BY SPREADBURY AND RODDY. RICKLEFS STATED RODDY KEPT GETTING CLOSE TO A PARKED VEHICLE. RICKLEFS STATED RODDY WAS STANDING WITH HER FEET CLOSE TOGETHER AND ARMS WERE CROSSED OVER. *How*

RICKLEFS STATED HE FELT HE SHOULD GO OUTSIDE HIS OFFICE TO MAKE SURE RODDY WAS NOT IN DANGER. RICKLEFS TOLD ME SPREADBURY EXITED HIS

VEHICLE IN A VERY AGITATED MANNTR. RICKLEFS DESCRIBED SPREADBURY'S ACTIONS WHILE SPEAKING WITH RODDY AS BEING VERY OVER DRAMATIC. RICKLEFS STATED THAT RODDY WAS AT HER VEHICLE WHEN SPREADBURY EXITED HIS VEHICLE. RICKLEFS STATED AND DEMONSTRATED THAT SPREADBURY RAISED AND PUMPED HIS HANDS. RODDY, RICKLEFS DESCRIBED SPREADBURY'S HAND AS BEING SHAPED LIKE A PISTOL. RICKLEFS STATED THAT MADE HIM FEEL VERY FRIGHTENED FOR RODDY'S SAFETY. RICKLEFS STATED IT APPEARED SPREADBURY WANTED A CONFRONTATION WITH RODDY. RICKLEFS DESCRIBED RODDY'S BEHAVIOR DURING THE CONVERSATION WITH SPREADBURY AS BEING VERY MEAK OR FRIGHTENED DUE TO RODDY'S BODY POSTURE. RICKLEFS STATED RODDY KEPT TRYING TO DISTANCE HERSELF FROM SPREADBURY.

I TOOK PHOTOGRAPHS OF THE VIEW THAT RICKLEFS HAD FROM HIS OFFICE. THE FOLLOWING IS A LIST OF PHOTOGRAPHS:

- #1. GENERAL PHOTO OF THE BITTERROOT PUBLIC LIBRARY
- #2. GENERAL PHOTO OF BITTERROOT LAND TRUST OFFICE BUILDING
- #3. CLOSE UP OUTSIDE PHOTOGRAPH OF RICKLEFS OFFICE
- #4. THE VIEW RICKLEFS HAS AT THE BITTERROOT PUBLIC LIBRARY

THE PHOTOGRAPHS HAVE BEEN TRANSFERRED TO A CD AND THE CD HAS BEEN TURNED INTO TO BE FILED.

I MADE PHONE CONTACT WITH SPREADBURY AND IDENTIFIED MYSELF AS A HAMILTON POLICE OFFICER. SPREADBURY STATED HE DID NOT WANT TO TALK WITH ME TODAY AND HUNG THE PHONE UP.

HAMILTON POLICE DEPARTMENT SGT STEVE SHAVELY HAS CHARGED SPREADBURY WITH CRIMINAL TRESPASS TO PROPERTY AT THE BITTERROOT PUBLIC LIBRARY. THIS CASE IS STILL PENDING IN HAMILTON CITY COURT. IT SHOULD BE FURTHER NOTED THAT RODDY IS A WITNESS ON PREVIOUS INCIDENTS THAT INVOLVE SEVERAL LIBRARY EMPLOYEES THAT RESULTED IN SPREADBURY BEING ORIGINALLY TRESPASSED FROM THE LIBRARY, WHICH ULTIMATELY LED TO SPREADBURY BEING CHARGED WITH CRIMINAL TRESPASS IN CASE 209CR001937.

THE FOLLOWING IS A LIST OF HAMILTON POLICE DEPARTMENT CASE REPORTS THAT INVOLVE SPREADBURY, RODDY AND OTHER LIBRARY EMPLOYEES: 209CR001281, 209CR001297, 209CR001589, 209CR001330, 209CR001932, AND 209CR001933.

I ASKED DISPATCH TO CHECK SPREADBURY FOR ANY COURT CONDITIONS. SPREADBURY RETURNED WITH HAMILTON CITY COURT CONDITIONS OF RELEASE. THE CONDITIONS STATE SPREADBURY MUST NOT CONTACT ANY WITNESSES OR VICTIMS ASSOCIATED WITH THIS CASE. I HAVE TURNED IN A COPY OF THE COURT CONDITIONS TO BE FILED.

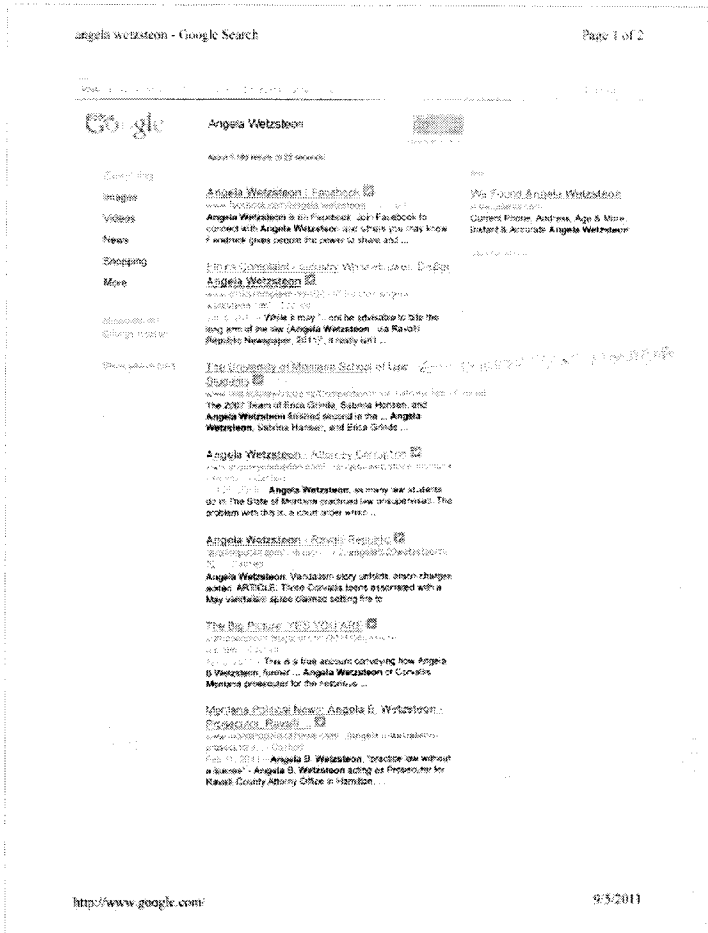
