1. This Affidavit is submitted in further support of Defendants City of Hamilton (“City”) and Bitterroot Public Library’s (“BPL”) Motion to Dismiss Plaintiff’s Claims for Failure to Comply With Court Order. [Docs. 293 and 294.]

2. William L. Crowley is a shareholder in the law firm of Boone Karlberg P.C. He is one of the attorneys representing the City and BPL in this action.

3. On May 29, 2012, the City and BPL filed a motion to dismiss Plaintiff’s remaining claims for failure to comply with the Court’s May 23, 2012, Order compelling his participation in preparing a final pretrial order. [Docs. 293 and 294.]

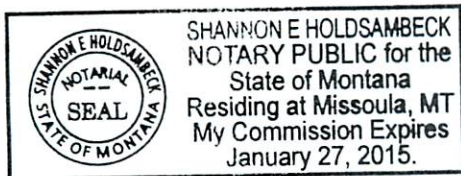


