This matter is before the court on its own motion. This court conducted an initial review of Plaintiff’s Complaint on October 14, 2008. (Filing No. 8.) In that Memorandum and Order, the court determined that several of Plaintiff’s claims failed to state a claim upon which relief may be granted. (*Id.*) Plaintiff was given until November 14, 2008, to file an amended complaint, in the absence of which this matter would only proceed as to Plaintiff’s Eighth Amendment safety claim against the individual Defendants. (*Id.* at CM/ECF p. 7.)

Plaintiff has not filed an amended complaint. Therefore, service of process may occur on the individual Defendants as set forth in this Memorandum and Order and in the court’s October 14, 2008, Memorandum and Order. Plaintiff’s Eighth Amendment medical claims and all claims against Defendants Douglas County Corrections and Douglas County Corrections Medical Department are dismissed.

IT IS THEREFORE ORDERED that:

1. All claims against Defendants Douglas County Corrections and Douglas County Corrections Medical Department are dismissed without prejudice. Plaintiff’s Eighth Amendment medical claims against the individual Defendants are also dismissed without prejudice;

2. This matter will proceed only against Defendants Newton, Curtis, and Russell-Cummins and only on Plaintiff's Eighth Amendment safety claim;

3. To obtain service of process on Defendants, Plaintiff must complete and return the summons forms which the Clerk of the court will provide. The Clerk of the court shall send THREE (3) summons forms and THREE (3) USM-285 forms to Plaintiff together with a copy of this Memorandum and Order. Plaintiff shall, as soon as possible, complete the forms and send the completed forms back to the Clerk of the court. In the absence of the forms, service of process cannot occur;

4. Upon receipt of the completed forms, the Clerk of the court will sign the summons form, to be forwarded with a copy of the Complaint to the U.S. Marshal for service of process. The Marshal shall serve the summons and Complaint without payment of costs or fees. Service may be by certified mail pursuant to Fed. R. Civ. P. 4 and Nebraska law in the discretion of the Marshal. The Clerk of the court will copy the Complaint, and Plaintiff does not need to do so;

5. Fed. R. Civ. Pro. 4 requires service of a complaint on a defendant within 120 days of filing the complaint. However, because in this order Plaintiff is informed for the first time of these requirements, Plaintiff is granted, on the court's own motion, an extension of time until 120 days from the date of this order to complete service of process;

6. Plaintiff is hereby notified that failure to obtain service of process on a defendant within 120 days of the date of this order may result in dismissal of this matter without further notice as to such defendant. A defendant has twenty (20) days after receipt of the summons to answer or otherwise respond to a complaint.;

7. The Clerk of the Court is directed to set a pro se case management deadline in this case with the following text: "**May 26, 2009**: Check for completion of service of summons;"

8. The parties are bound by the Federal Rules of Civil Procedure and by the Local Rules of this court. Plaintiff shall keep the court informed of his current address at all times while this case is pending. Failure to do so may result in dismissal.
