This matter is before the court on its own motion. On June 22, 2011, Defendants filed a "Notice of Settlement" in this matter. (Filing No. <u>37</u>.) In the Notice, Defendants represent that Plaintiff executed a document entitled "SETTLEMENT AND RELEASE OF ALL CLAIMS" on March 5, 2011. (*Id.* at CM/ECF p. 1.) Defendants also represent that Plaintiff signed a Motion to Dismiss With Prejudice on March 5, 2011, which she provided to counsel for Defendants, but neglected to file in this court. (*Id.*) Defendants attached the purported settlement agreement and motion to dismiss to their Notice. (*See Id.* at CM/ECF pp. 3-7.) Plaintiff has not responded in any way to Defendants' Notice of Settlement.

IT IS THEREFORE ORDERED that:

1. Plaintiff shall have 20 days in which to show cause why this matter should not be dismissed with prejudice pursuant to the documents filed by Defendants, which appear to be a settlement agreement signed by Plaintiff and motion to dismiss with prejudice signed by Plaintiff. In the absence of a response by Plaintiff, the court will dismiss this matter with prejudice and without further notice. 2. The clerk's office is directed to set a pro se case management deadline in this matter using the following text: August 31, 2011: Deadline for Plaintiff to Show Cause.
