Petitioner has filed a Petition for Writ of Habeas Corpus under <u>28 U.S.C.</u> § <u>2254</u> (filing no. <u>1</u>), a Motion for Leave to Proceed in Forma Pauperis (filing no. <u>2</u>), and a copy of his institutional trust account statement (filing no. <u>3</u>).
