**MEMORANDUM
AND ORDER**

Plaintiff has moved to compel Defendant to respond to Plaintiff's Interrogatories No. 26, 27, and 28. Plaintiff's motion concedes her discovery exceeds the permissible number of interrogatories under [Fed.R.Civ.P. 33\(a\)](#), and "Defendant is not bound to answer them." ([Filing No. 24](#)).

Plaintiff appears to be requesting leave to serve, and an order requiring defendant to answer, more than 25 interrogatories. The court cannot address this argument without reviewing Plaintiff's interrogatories and deciding whether, based on the allegations in the pleadings and the information requested, exceeding the numerical limit imposed by the federal discovery rules¹ is warranted. Plaintiff has not filed a copy of the interrogatories served and those which remain unanswered.

Accordingly,

IT IS ORDERED that Plaintiff's motion to compel, ([Filing No. 24](#)), is denied.
