This matter is before the court on its own motion. The plaintiff was recently granted leave to amend his complaint to add parties. Filing No. 228, Order; Filing No. 230, Amended Complaint. This is an action for deprivation of constitutional rights brought pursuant to 42 U.S.C. § 1983.
