This case was closed after judgment was entered pursuant to a settlement agreement between the parties (<u>filing 10</u>). An order related to the settlement agreement states that "the undersigned retains continuing jurisdiction over this case and the parties to construe and enforce the settlement agreement." (<u>Filing 9</u>, at 2.)

The parties' settlement agreement (<u>filing 10</u>) provides that "John J. McGee, Ph.D., shall be appointed as the Independent Expert to monitor the State's implementation of this Settlement Agreement," and that Dr. McGee "shall submit monthly statements to the Court . . . detailing all expenses the Independent Expert

incurred during the prior month." (Filing 10, at 4-5.) The agreement also permits payment to consultants who assist the independent expert. The agreement allows parties seven business days from receipt of the independent expert's monthly statements to file any comments or objections regarding the statements. (Filing 10, at 6.) After such comments or objections are submitted, the court is to review the matter and "order the clerk to make the appropriate payments" to the independent expert.

On July 20, 2009, independent expert John J. McGee, Ph.D., filed motions for reimbursement for professional services and expenses in the amounts of \$5,405.00 for March 2009 (filing $\underline{29}$); \$10,580.00 for April 2009 (filing $\underline{30}$); \$9,425.00 for May 2009 (filing $\underline{31}$); and \$13,250.00 for June 2009 (filing $\underline{32}$).

As no objections or comments regarding any of the above reimbursement requests were filed, I shall order that payment be made to John J. McGee, Ph.D., for professional services and expenses in the amounts requested pursuant to the terms of the settlement agreement.

Accordingly,

IT IS ORDERED:

1. The motions for reimbursement (filings 29, 30, 31, 32) are granted, and within 10 days of the date of this order, the Clerk of the United States District Court for the District of Nebraska shall disburse funds for the consulting services and

expenses of independent expert John J. McGee, Ph.D., the amounts of \$5,405.00 for

March 2009; \$10,580.00 for April 2009; \$9,425.00 for May 2009; and \$13,250.00 for

June 2009.

2. Such funds shall be paid from the interest-bearing account set up by the

Clerk of Court pursuant to this court's prior order (<u>filing 9</u>).

3. As provided in this court's prior order (<u>filing 9</u>), the "Clerk is authorized

to deduct from any monies deposited with the Clerk a fee of 10% of the interest

earned each time funds are disbursed."

4. As provided in the parties' settlement agreement (<u>filing 10</u>, at 6), and

within 45 days of the date of this order, the defendants shall replenish the above-

described interest-bearing account with the full amount paid by the Clerk of Court to

independent expert John J. McGee, Ph.D., in order to restore the account's total to

\$100,000.00.
