- The Stipulation of Dismissal of Claims Against and By Defendants and Motion to Dismiss Defendants (Filing No. 103) is approved;
- 2. American Guarantee's claims against Defendants in American Guarantee's Amended Complaint (Filing No. 74 at pp. 1-8) are dismissed with prejudice<sup>1</sup>;

3. Defendants' claims against Columbia Casualty in Defendants' Amended Third-Party Complaint (Filing No. 60) are dismissed with prejudice;

4. Columbia Casualty's claims against Defendants in Columbia Casualty's Amended Answer and Counterclaim (Filing No. 62 at pp. 4-9) are dismissed with prejudice; and

5. Each party shall pay its own costs.
