- 2. Failure to comply with this Memorandum and Order will result in dismissal of this matter as to Plaintiff without further notice.
- 3. The Clerk of the court is directed to send to Plaintiff the Form AO240, Application to Proceed Without Prepayment of Fees and Affidavit.
- 4. The Clerk of the court is directed to set a pro se case management deadline in this matter with the following text: April 25, 2013: Check for MIFP or payment.
