11 **IT IS HEREBY STIPULATED AND AGREED**, pursuant to FRCP 6 and LR 6-1, by and

12 between James J. Pisanelli, counsel for Defendant AutoZone, Inc., and Stanley W. Parry, counsel  
13 for Plaintiff, that this Court extend time for serving upon AutoZone its Statement of the Basis for  
14 Its Claim for Preliminary Injunctive Relief and the Nature of the Relief It Seeks on Those Claims  
15 (the "Statement") to August 27, 2004. The Court Order dated August 6, 2004 would have required  
16 that the Statement be served upon AutoZone by August 23, 2004. As grounds, the Parties would  
17 show the court the following:

19 1. Although Plaintiff was granted fifteen (15) days from the date of the August 6, 2004  
20 Order to serve the statement upon Autozone, the Order was not mailed to the Parties until August  
21 10, 2004, and was received by Plaintiff's local counsel late in the afternoon of August 11, 2004,  
22 effectively leaving Plaintiff with less than twelve (12) days in which to comply with the Order.

24 2. The extension of time will not prejudice Autozone, Inc., as no motion in this matter  
25 is currently pending before the Court.

27 3. Plaintiff agrees to send a copy of the Statement to the offices of Alston & Bird LLP  
28 via facsimile transmission by 2:00 p.m. Pacific Standard Time on August 27, 2004.




4. The extension is requested so that justice may be done in this cause, and not for delay.
