

1 POINTS AND AUTHORITIES IN SUPPORT OF PLAINTIFF'S MOTION TO TAKE
2 JUDICIAL NOTICE OF CERTIFICATES OF COPYRIGHT REGISTRATION

3 Rule 201(b)(2) of the Federal Rules of Evidence permits a
4 Court to take judicial notice of facts which are "capable of
5 accurate and ready determination by resort to sources whose
6 accuracy cannot reasonably be questioned." Certificates of
7 Registration of copyrighted works are appropriate for judicial
8 notice. According to the Court in Warren v. Fox Family
9 Worldwide, Inc.:

10 Copyright certificates are the type of documents that the
11 court may judicially notice under Rule 201(b)(2). See,
12 e.g., Oroamerica Inc. v. D & W Jewelry Co., Inc., 2001 U.S.
13 App. LEXIS 10743, 10 Fed. Appx. 516, 2001 WL 537780, *1, n.
14 4 (9th Cir. May 14, 2001) (Unpub. Disp.) (granting a
15 request that the court take judicial notice of a
16 supplemental copyright registration certificate); Metro
