4. A previous stipulated request for an extension of time for Defendant to answer, plead or otherwise respond to Plaintiff's Complaint set the due date for Defendant's response as July 25, 2006.

5. An additional extension is necessary for counsel to continue settlement negotiations. The parties have initiated communications in an effort to resolve this matter pursuant to settlement and have made good progress in their efforts. In the past few days, the parties have exchanged settlement offers that would resolve all of the issues in the case, and those offers are under consideration. The requested extension will allow the parties to continue to focus on these discussions.

6. Counsel for Defendant spoke with Plaintiff's counsel who is in agreement with the request for an extension until August 1, 2006 for Defendant to answer, plead or otherwise respond to Plaintiff's Complaint.

7. This request is made in good faith and not for the purpose of delay.
