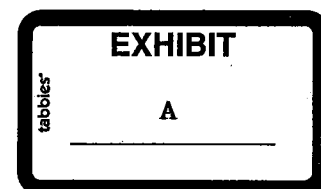

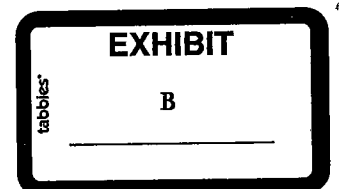
History/Values

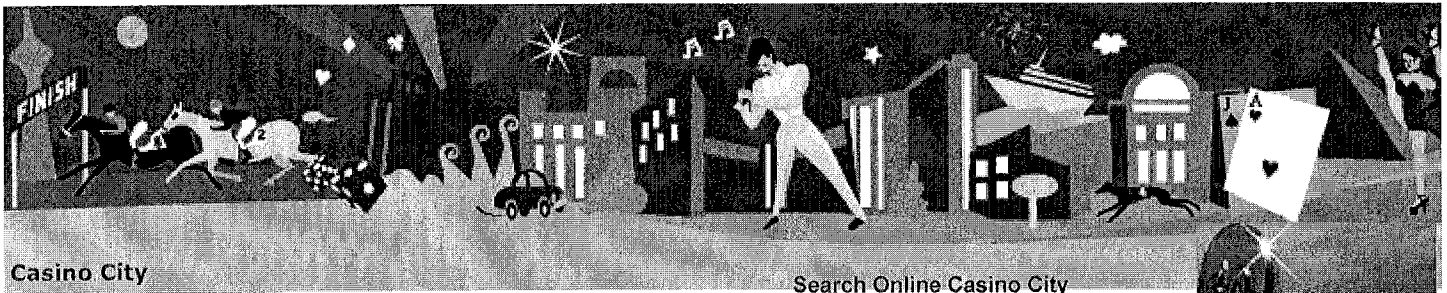
Founded in 1998, IQL is a pioneer in online gaming. Since then, IQL has successfully processed billions in online gaming transactions. IQL distinguishes itself by its focus on call centre management, productivity software and sports and race book services, whereas many of our competitors focus only on online casino games (blackjack, roulette, backgammon, slots). In contrast with the online casino market, there are significant barriers to entry in the enterprise-scale sports book software market due to the relative complexity and dynamic nature of the international sports wagering markets. Despite relatively recent visibility of online poker, for example, sports wagering continues to dominate the online gaming market in terms of market share and wagering volume, representing more aggregate 'handle' than casino, backgammon and poker.

In 2005, IQL acquired a full suite of Internet Banking Software, IQ-Bank and IQ-Card. IQL has deployed the banking software to enable consumers to transfer money securely and efficiently in exchange for a fee. Simultaneously, IQL completed an investment by a new control group with 28 years of experience in financial payments software engineering. IQL's new CEO has been the lead architect on some of the largest, most well known financial networks in the world, including Honor ATM Network (now Star) and GTE Financial Services. In partnership with the Internet gaming industry and the government of Antigua, IQL is uniquely poised to grow another world-leading payments network.

IQL is backed by several institutional investors, including one of the largest independent wealth management groups in Canada, which lead a C\$25 million equity placement by IQL. IQL will continue to seek value accretive strategic acquisitions.

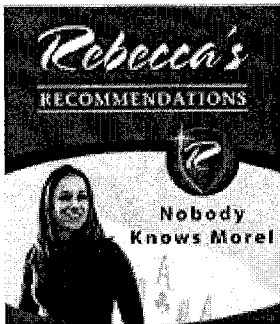

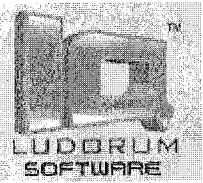

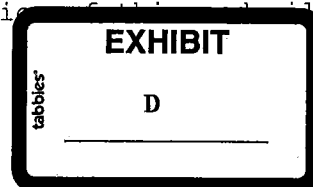
Following this software acquisition, IQL anticipates Betcorp will continue to utilise IQ-Softtech for an extended period into the future. IQL also intends to offer Betcorp secured payment solutions as part of the ongoing business relationship. IQL charges transaction fees for payment solutions, which generate recurring fee income for the Company that is tied to wagering volume. Betcorp's operating affiliate in Antigua, Tasman Gaming operates a leading Internet gaming site at www.betwts.com.

IQL has a suite of Internet gaming software, including IQ-Softtech, the second sportsbook software product developed by the Company. Betcorp has been on this platform for over five years and its strong internal development and IT function has already made considerable investment in peripheral software and bolt-on products around this IQL system.

Both IQL and Betcorp have significant Antiguan operations and will continue to work closely together.

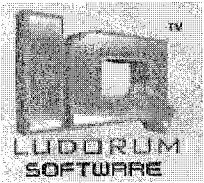

Strategic Investment in Global Bank of Commerce Ltd.

London/Antigua, 29 June 2006: The Board of IQ-Ludorum PLC ('IQL' or 'Company') has negotiated definitive terms to an investment in Global Bank of Commerce Ltd ('GBC'), a full service bank licensed and regulated in Antigua that has been in operation for 23 years.

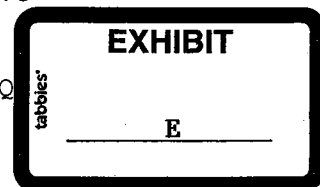
GBC operates in three primary areas (i) private wealth management, (ii) commercial banking and (iii) e-commerce and transaction processing, including the issuance of prepaid debit cards. GBC is a Principal Member of VISA and MasterCard card associations and has issued over one million VISA debit cards to consumers. In its e-commerce business segment, GBC earns fees paid by online businesses using the bank to accept credit cards on their behalf ('merchant acquiring'). GBC also earns fees from prepaid debit cardholders for all card transactions, such as for facilitating customer withdrawals from ATMs.

GBC is the issuing bank for the First Pay prepaid debit card for IQL (www.first-pay.com) and the PayTru prepaid debit card (www.paytrucard.com), an affiliate of IQL. GBC has used the i24 Bank debit card platform for over two years under contract.

IQL will purchase 15,000 shares of non voting Preferred Stock for cash consideration of \$15,000,000. Closing is expected to take place in July, subject to regulatory approval. The non voting Preferred Stock provides IQL with a fixed coupon of 8% and a right to 66% of the e-commerce profits generated by GBC. IQL will use cash previously received by IQL from a share issue to fund the \$15,000,000 investment.

The Board believes IQL can generate a superior rate of return of over 50% per annum on its invested capital in the bank. The transaction also gives IQL better access to the established global infrastructure of VISA and MasterCard through GBC's membership. Since the number of authorised banks worldwide willing to perform internet-based payment processing is very limited, having access to a member bank through this investment represents a significant competitive advantage for IQL in addition to a high rate of return.

In connection with the investment, Mike Muscato, Chairman and CEO of IQ



be appointed to the board of directors of GBC, again subject to regulatory approval.

Mike Muscato commented:

'In a short period of time, we have transformed IQL into a full service financial technology company with state-of-the-art prepaid debit card banking technology. Our relationship with GBC enhances our vertical integration strategy in the online payments supply chain, which now includes each of eGaming software, payments, prepaid debit and a strategic stake in a full service commercial bank which provides us with a significant share of e-commerce profits generated'

As a VISA Principal Member, GBC has the independence to design and operate its own card programs and make its own merchant acquiring risk management decisions, subject to card association by-laws. GBC plans to use its expanded capital base resulting from the IQL investment to grow its e-commerce operations based on its enhanced balance sheet and significantly reduced card association fees arising from the new capital base. IQL and GBC have recently jointly leased an additional 20,000 square foot newly constructed facility in Antigua to accommodate the growth of their e-commerce operations.

Although most commentators believe that BetOnSports has been targeted to get at its fugitive founder, Gary Kaplan, the broad nature of the charges suggests that the Department of Justice is using the case to send a warning to the wider internet gambling sector.

It had been assumed that the greater uncertainty over the legality of casino and poker websites meant that the Department was attacking only sportsbooks. However, BetOnSports, which operates websites including BoSPOKER.com and BoSCASINO.com, said yesterday: "In relation to the temporary restraining order, the company confirms that it has temporarily discontinued the provision of all of its US-facing services."

The restraining order states that the group is barred from "operating an illegal gambling business through internet websites". It lists 711 websites linked to BetOnSports, Mr Kaplan and the other defendants, including numerous casino and poker sites.

The restraining order remains in place until a formal hearing, but a spokeswoman for BetOnSports confirmed it was appealing. "The order is unreasonable and we are appealing against it."

Shares of PartyGaming, down 22 per cent this week, bounced 9p to 94¼p on false rumours that BetOnSports had sealed a deal with the Department of Justice.

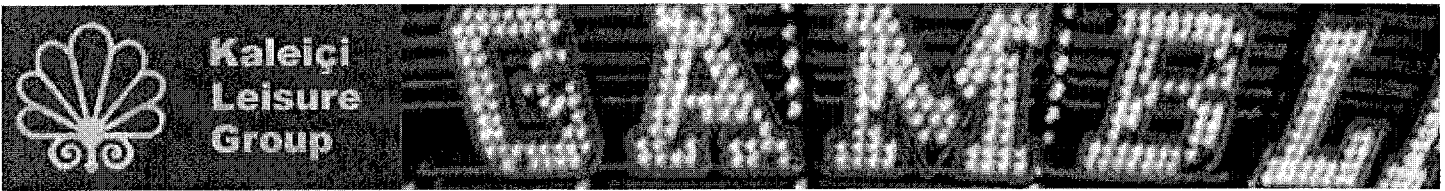

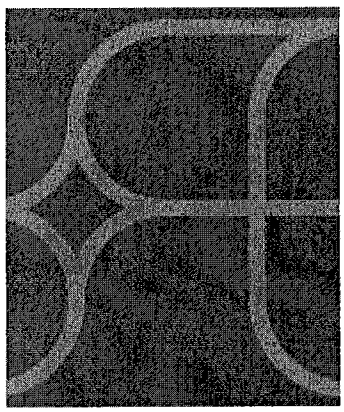
