**STATUS REPORT OF PLAINTIFF 1<sup>ST</sup> TECHNOLOGY LLC  
IN ADVANCE OF AUGUST 17, 2007 STATUS CONFERENCE**

During the Status Conference held on June 14, 2007, the Court requested that Plaintiff 1<sup>st</sup> Technology LLC (“1<sup>st</sup> Technology”) prepare and submit to the Court proposed Letters Rogatory directed to the Aruban authority responsible for service of extraterritorial legal process in connection with the service of the summons and complaint issued to Defendant Kolyma Corporation, A.V.V. (“Kolyma”). Pursuant to the Court’s request, 1<sup>st</sup> Technology researched the process of preparing Letters Rogatory and discovered that the State Department of the United States (the U.S. department responsible for transmitting Letters Rogatory to

foreign governments) will not transmit Letters Rogatory to any country that is a signatory to The Hague Convention. Aruba is signatory nation to The Hague Convention. Accordingly, the State Department will not transmit a Letters Rogatory to Aruba on behalf of the Court.

1<sup>st</sup> Technology has further confirmed with the process server that the process server has yet to receive confirmation from the Aruban authority that the summons and complaint have been served on Kolyma.
