**JUDGMENT AGAINST BOBBY LEN
FRANKLIN**


24 Plaintiffs BWD Properties 2, LLC, BWD Properties 3, LLC, and BWD Properties 4,
25 LLC (collectively "Plaintiffs"), by motion, requested that this Court issue a judgment against
26 Defendant Bobby Len Franklin ("Franklin"), based on the following.

1 On April 13, 2015, this Court ordered (ECF No. 165) that Franklin be sanctioned in the
2 amount of \$5,260.50 for his bad faith and willful violation of the permanent injunction issued in
3 this case.

4 Plaintiffs made demand on Franklin demanding the sanctions be paid; however, Franklin
5 has failed to pay any portion of the sanctions. On June 17, 2015 Plaintiffs, by motion (ECF No.
6 172), requested that this Court issue a Judgment for the sanctions awarded against Franklin.

7 IT IS HEREBY ORDERED ADJUDGED AND DECREED that Plaintiffs shall have and
8 recover Judgment against Bobby Len Franklin, in the amount of Five Thousand Two Hundred
9 Sixty Dollars and Fifty Cents (\$5,260.50), together with interest thereon at the statutory rate
10 from April 13, 2015 until all principal and interest is paid in full, plus costs and reasonable
11 attorney's fees.
