**STIPULATED FINAL JUDGMENT, ORDER FOR COMPENSATORY CONTEMPT
RELIEF, AND MODIFIED ORDER FOR PERMANENT INJUNCTION AND OTHER
EQUITABLE RELIEF AS TO CRYSTAL EWING**

Plaintiff, the Federal Trade Commission (“Commission” or “FTC”), filed its Motion for Contempt against Defendant Crystal Ewing based on Defendant’s violation of the Order entered by this Court on June 15, 2007 (“2007 Order”). The Commission and Defendant Crystal Ewing stipulate to the entry of this Stipulated Final Judgment, Order for Compensatory Contempt Relief, and Modified Order for Permanent Injunction and Other Equitable Relief (“Order”) to resolve all matters in dispute in this contempt proceeding.

THEREFORE, IT IS ORDERED as follows:

FINDINGS

1. This Court has jurisdiction over this matter.
 2. The Commission’s Motion for Contempt and subsequent filings allege that Defendant Crystal Ewing violated the Court’s ban on prize promotion activities, and that consumers suffered injury of \$9,513,084 as a result of such violations.
 3. Specifically, Defendant Ewing, through her work with Glen Burke and Puzzles Unlimited, LLC, violated the 2007 Order’s ban on prize promotion activities.

1 DEFINITIONS

2 For the purpose of this Order:

3 1. "Assisting" means providing substantial assistance or support to any person. For
4 purposes of this Order, providing substantial assistance or support includes, but is not limited to:
5 (a) preparing, printing or transmitting invoices; (b) recording or verifying sales solicitations; (c)
6 performing customer service functions including, but not limited to, receiving or responding to
7 consumer complaints, obtaining or receiving identifying and financial information from
8 consumers, and communicating with consumers on behalf of the seller or telemarketer; (d)
9 developing, providing or arranging for the development or provision of sales scripts or any other
10 marketing material; (e) verifying, processing, fulfilling or arranging for the fulfillment of orders;
11 (f) developing, providing or arranging for the provision of names of potential customers; (g)
12 collecting or arranging for the collection of accounts receivable or other amounts owed; (h)
13 providing or arranging for the provision of post office boxes or the services of commercial mail
14 receiving agencies; or (i) performing or providing marketing services of any kind.

15 2. "Commerce" means as defined in Section 4 of the FTC Act, 15 U.S.C. § 44.

16 3. "Defendant" means Crystal Ewing.

17 4. "Direct mail marketing" means solicitations or other advertisements sent through
18 the U.S. Postal Service or other commercial mail carrier.

19 5. "Person" means a natural person, an organization, or other legal entity, including
20 a corporation, partnership, sole proprietorship, limited liability company, association,
21 cooperative, or any other group or combination acting as an entity.

22 6. "Telemarketing" means a plan, program, or campaign, which is conducted to
23 induce the purchase of goods or services or a charitable contribution, by use of one or more
24 telephones, and which involves more than one interstate phone call.

25 7. The term "including" in this Order means "including without limitation."

I

BAN ON DIRECT MAIL MARKETING

IT IS FURTHER ORDERED that Defendant is permanently restrained and enjoined from engaging, participating, or assisting others in the advertising, promoting, offering for sale, selling, or distributing of any product, program, or service by direct mail marketing.

II

PROHIBITION AGAINST MISPRESENTATIONS

(Supersedes Section II of 2007 Order)

IT IS FURTHER ORDERED that Defendant, her successors and assigns, and her officers, agents, directors, servants, employees, and attorneys, and those persons in active concert or participation with them who receive actual notice of this Order by personal service or otherwise, whether acting directly or through any person, trust, corporation, subsidiary, division or other device, or any of them, in connection with the advertising, promoting, telemarketing, offering for sale, selling or distributing of any good or service are hereby permanently restrained and enjoined from misrepresenting, or assisting others in misrepresenting, expressly or by implication, any fact material to a consumer's decision to purchase goods or services.

III

MONETARY JUDGMENT AND COMPENSATORY CONTEMPT RELIEF

IT IS FURTHER ORDERED that:

A. Judgment in the amount of nine million five hundred thirteen thousand and eighty-four dollars (\$9,513,084) is entered in favor of the Commission against Defendant, as compensatory contempt relief.

B. The facts alleged in the FTC's Memorandum in Support of Its Motion to Hold Crystal A. Ewing in Contempt (Dkt. #11-1 and accompanying exhibits) and the FTC's

1 subsequent filings (Dkt. ##17, 28, and 34) related to the FTC's contempt motion will be taken as
2 true, without further proof, in any subsequent civil litigation by or on behalf of the Commission
3 in a proceeding to enforce its rights to any payment or monetary judgment pursuant to this Order,
4 such as a nondischargeability complaint in any bankruptcy case.

5 C. The facts alleged in the FTC's Memorandum in Support of Its Motion to Hold
6 Crystal A. Ewing in Contempt (Dkt. #11-1 and accompanying exhibits) and the FTC's
7 subsequent filings (Dkt. ##17, 28, and 34) establish all elements necessary to sustain an action by
8 the Commission pursuant to Section 523(a)(2)(A) of the Bankruptcy Code, 11 U.S.C. §
9 523(a)(2)(A), and this Order will have collateral estoppel effect for such purposes.

10 D. Defendant acknowledges that her Taxpayer Identification Numbers (Social
11 Security Numbers or Employer Identification Numbers) may be used for collecting and reporting
12 on any delinquent amount arising out of this Order, in accordance with 31 U.S.C. §7701.

13 E. All money paid to the Commission pursuant to this Order may be deposited into a
14 fund administered by the Commission or its designee to be used for equitable relief, including
15 consumer redress and any attendant expenses for the administration of any redress fund. If a
16 representative of the Commission decides that direct redress to consumers is wholly or partially
17 impracticable or money remains after redress is completed, the Commission may apply any
18 remaining money for such other equitable relief (including consumer information remedies) as it
19 determines to be reasonably related to Defendant's practices alleged in the Complaint. Any
20 money not used for such equitable relief is to be deposited to the U.S. Treasury as disgorgement.
21 Defendant has no right to challenge any actions the Commission or its representatives may take
22 pursuant to this Subsection.

IV

CUSTOMER INFORMATION
(supersedes Section III of 2007 Order)

IT IS FURTHER ORDERED that Defendant, her officers, agents, servants, and employees, and attorneys, and all other persons in active concert or participation with any of them, who receive actual notice of this Order, are permanently restrained and enjoined from directly or indirectly:

A. Failing to provide sufficient customer information to enable the Commission to efficiently administer consumer redress. If a representative of the Commission requests in writing any information related to redress, Defendant must provide it, in the form prescribed by the Commission, within 14 days.

B. Disclosing, using, or benefitting from customer information, including the name, address, telephone number, email address, social security number, other identifying information, or any data that enables access to a customer's account (including a credit card, bank account, or other financial account), that any Defendant obtained prior to entry of this Modified Order in connection with any prize promotion activity.

C. Failing to destroy such customer information in all forms in their possession, custody, or control within 30 days after receipt of written direction to do so from a representative of the Commission. Provided, however, that customer information need not be disposed of, and may be disclosed, to the extent requested by a government agency or required by law, regulation, or court order.

V

ORDER ACKNOWLEDGMENTS

IT IS FURTHER ORDERED that Defendant obtain acknowledgments of receipt of this Order:

1 means of advertising, marketing, and sales; (d) describe in detail whether and
2 how Defendant is in compliance with each Section of this Order; and (e)
3 provide a copy of each Order Acknowledgment obtained pursuant to this
4 Order, unless previously submitted to the Commission;

- 5 2. Additionally, Defendant must: (a) identify all telephone numbers and all
6 physical, postal, email and Internet addresses, including all residences; (b)
7 identify all business activities, including any business for which such
8 Defendant performs services whether as an employee or otherwise and any
9 entity in which such Defendant has any ownership interest; and (c) describe in
10 detail such Defendant's involvement in each such business, including title,
11 role, responsibilities, participation, authority, control, and any ownership.

12 B. For 20 years after entry of this Order, Defendant must submit a compliance
13 notice, sworn under penalty of perjury, within 14 days of any change in the following:

- 14 1. Defendant must report any change in: (a) any designated point of contact; or
15 (b) the structure of any entity that Defendant has any ownership interest in or
16 controls directly or indirectly that may affect compliance obligations arising
17 under this Order, including: the creation, merger, sale, or dissolution of the
18 entity or any subsidiary, parent, or affiliate that engages in any acts or
19 practices subject to this Order.
- 20 2. Additionally, Defendant must report any change in: (a) name, including
21 aliases or fictitious names, or residence address; or (b) title or role in any
22 business activity, including any business for which such Defendant performs
23 services, whether as an employee or otherwise, and any entity in which such
24 Defendant has any ownership interest, and identify the name, physical
25 address, and any Internet address of the business or entity.

1 C. Defendant must submit to the Commission notice of the filing of any bankruptcy
2 petition, insolvency proceeding, or any similar proceeding by or against such Defendant within
3 14 days of its filing.

4 D. Any submission to the Commission required by this Order to be sworn under
5 penalty of perjury must be true and accurate and comply with 28 U.S.C. § 1746, such as by
6 concluding: “I declare under penalty of perjury under the laws of the United States of America
7 that the foregoing is true and correct. Executed on: _____” and supplying the date, signatory’s
8 full name, title (if applicable), and signature.

9 E. Unless otherwise directed by a Commission representative in writing, all
10 submissions to the Commission pursuant to this Order must be emailed to DEbrief@ftc.gov or
11 sent by overnight courier (not the U.S. Postal Service) to: Associate Director for Enforcement,
12 Bureau of Consumer Protection, Federal Trade Commission, 600 Pennsylvania Avenue, NW,

16 RECORD KEEPING PROVISIONS 17 (supersedes Section VIII of 2007 Order)

18 **IT IS FURTHER ORDERED** that Defendant must create certain records for 20 years
19 after entry of this Order, and retain each such record for 5 years. Specifically, Defendant, must
20 create and retain the following records:

21 A. Accounting records showing the revenues from all products, programs, or services
22 sold, all costs incurred in generating those revenues, and the resulting net profit or loss;

23 B. Personnel records showing, for each person providing services, whether as an
24 employee or otherwise, that person’s: name, addresses, telephone numbers; job title or position;
25 dates of service; and, if applicable, the reason for termination;

1 C. All records necessary to demonstrate full compliance with each provision of this
2 Order, including all submissions to the Commission; and

3 D. A copy of each unique advertisement or other marketing material.

5 VIII

6 COMPLIANCE MONITORING 7 (supersedes Section VII of 2007 Order)

8 **IT IS FURTHER ORDERED** that, for the purpose of monitoring Defendant's
9 compliance with this Order:

10 A. Within 14 days of receipt of a written request from a representative of the
11 Commission, Defendant must: submit additional compliance reports or other requested
12 information, which must be sworn under penalty of perjury; appear for depositions; and produce
13 documents, for inspection and copying. The Commission also is authorized to obtain discovery,
14 without further leave of court, using any of the procedures prescribed by Federal Rules of Civil
15 Procedure 29, 30 (including telephonic depositions), 31, 33, 34, 36, 45, and 69.

16 B. For matters concerning this Order, the Commission is authorized to communicate
17 directly with each Defendant. Defendant must permit representatives of the Commission to
18 interview any employee or other person affiliated with any Defendant who has agreed to such an
19 interview. The person interviewed may have counsel present.

20 C. The Commission may use all other lawful means, including posing, through its
21 representatives, as consumers, suppliers, or other individuals or entities, to Defendant or any
22 individual or entity affiliated with Defendant, without the necessity of identification or prior
23 notice. Nothing in this Order limits the Commission's lawful use of compulsory process,
24 pursuant to Sections 9 and 20 of the FTC Act, 15 U.S.C. §§49, 57b-1.


