extension of time.**

1 Pursuant to LR 7-1 and LR 6-2, Plaintiffs, by and through their counsel of record, and
2 Defendants, by and through their counsel of record, hereby stipulate to extend the time for
3 Plaintiffs to file their Reply in Support of their Request for Ruling regarding Plaintiffs' Motion
4 to Compel from April 10, 2009 to April 14, 2009.

5 Pursuant to this Court's Order of April 2, 2009, Plaintiffs' Reply in support of their
6 Request for Ruling was to be filed on April 10, 2009. Pursuant to the April 2, 2009 Order,
7 Defendants timely filed their Opposition on April 8, 2009. Plaintiffs are requesting an extension
8 of time to file their Reply, and Defendants have agreed not to oppose Plaintiffs' request, because
9 Plaintiffs' counsel are currently in the process of preparing for trial in another matter currently
10 pending in the United States District Court for the Eastern District of California. In that case,
11 trial exhibits are required to be marked and exchanged on April 9, 2009 and Motions In Limine
12 are due on April 10, 2009. As Plaintiffs' counsel did not receive Defendants' Opposition until
13 the afternoon of April 8, 2009, and the Opposition is lengthy with declarations and exhibits
14 totalling over 350 pages, Plaintiffs require additional time to prepare and file their Reply. This is
15 the first request by Plaintiffs and/or Defendants for an extension of time relating to the pending
16 Request For Ruling. Accordingly, Plaintiffs and Defendants hereby stipulate to extend the time
