STIPULATED DISCOVERY PLAN AND
SCHEDULING ORDER

15 SPECIAL SCHEDULING REVIEW REQUESTED

16 Pursuant to, and in compliance with Local Rule 26-1 of the Rules of Practice of the
17 United States District Court for the District of Nevada and the Court's Order of July 3, 2008, the
18 parties hereby submit this stipulated Discovery Plan and Scheduling Order.
19

20 1. DISCOVERY CUT OFF DATE:

21 A. The first Defendants to answer or otherwise appear were Defendants Forum
22 Shops, LLC, Forum Developers Limited Partnership, Simon Property Group Limited Partnership
23 and Simon Property Group, Inc. on March 17, 2008. Defendants Caesars Palace Corp and
24 Caesars Palace Realty Corp. first appeared in this action on July 1, 2008.

26 B. The parties require 270 days to conduct discovery. Ninety (90) additional days
27 are required for discovery due to the number of depositions required (estimated 20 to 30), the
28 complexity of the issues and a five month stipulated stay.

1 C. Discovery shall close 270 days after the Court enters its ruling on the current
2 Motions to Dismiss. For purposes of fixing the calendar dates required by LR 26-1, it is
3 assumed that the Court will enter its ruling on the current Motions to Dismiss on September 1,
4 2008. It is anticipated, however, that if the ruling is entered significantly after that date, one or
5 more of the parties may request that the dates set forth herein be modified. Nothing herein
6 precludes any party from requesting a further modification of the dates set forth herein for
7 appropriate good cause. Subject to the foregoing, discovery shall close May 30, 2009.

9 D. Discovery shall not begin until the current Motions to Dismiss are decided.

10 E. Initial discovery disclosures are due July 23, 2008.

11 2. AMENDING THE PLEADINGS AND ADDING PARTIES

12 The last day to file motions to amend the pleadings or to add parties shall be March
13 1, 2009.

14 3. DISCLOSURE OF EXPERTS

15 A. The last day to disclose experts shall be March 31, 2009.

16 B. The last day to disclose rebuttal experts is April 30, 2009.

17 4. DISPOSITIVE MOTIONS

18 The last day to file dispositive motions is June 29, 2009.

19 5. PRETRIAL ORDER

20 A. The joint pretrial order shall be filed on or before July 29, 2009.

21 B. If dispositive motions are filed, the date for filing the joint pretrial order shall be
22 suspended until thirty (30) days after the decision on the dispositive motions or until further
23 order of court. The pretrial disclosures required by Federal Rule of Civil Procedure 26(a)(3) and
24 any objections thereto are to be included in the pretrial order.
