1. The Court previously granted the parties’ stipulation (#26) to allow Defendant
an extension to file a response to Plaintiff’s Complaint in the above-entitled matter.

2. Defendant filed a Special Appearance of Harry Kakavas and Motion to Dismiss
First Claim for Relief Pursuant to Rule 12(b)(6) (the “*Motion*”) (#27) on May 11, 2009.

3. Plaintiff’s response to Defendant’s Motion would customarily be due on May

1 29, 2009.

2 4. The parties appear to have reached a tentative settlement of this action and are in
3 the process of attempting to finalize and document the terms of the settlement.

4 5. The parties agree that this action is stayed until June 16, 2009 so that the parties
5 may attempt to finalize their settlement and document the same.

6 6. The parties agree that Plaintiff's response to Defendant's Motion (#27) shall be
7 due on June 17, 2009 in the event that the parties are not able to finalize the settlement and file
8 an appropriate document herein in the interim.
