 23 TRUST CO. INC., a Nevada Corporation, filed by Plaintiffs, ZIPLINK, INC., a Delaware
 24 Corporation; ZACHS FAMILY LIMITED PARTNERSHIP NUMBER ONE, a Connecticut
 25 Partnership; and HENRY M. ZACHS, (“Plaintiffs”), by and through their counsel of the law firm
 26 of CALLISTER & FRIZELL, and the Court having considered said Application, and good cause
 27 appearing therefor,

1 IT IS HEREBY ORDERED, that STANDARD TRANSFER & TRUST CO. INC.
2 (“STANDARD TRANSFER”) shall have its person most knowledgeable appear and be examined
3 under oath at the law offices of **CALLISTER & FRIZELL, 8275 S. Eastern Ave., Ste. 200, Las**
4 **Vegas, Nevada 89123, on October 4, 2011 at 10:00 a.m.** on said day, at which time
5 STANDARD TRANSFER will produce any and all books, papers and records now in its
6 possession and/or control that evidence or indicate in any way any of the property, assets and/or
7 liabilities of Defendant, STANDARD TRANSFER & TRUST CO. INC. STANDARD
8 TRANSFER shall provide all documents of any kind evidencing any interest in real or personal
9 property or cash, including, but not limited to, all bank account statements, 401(k) account, IRA
10 (Roth), and/or other retirement account statements, stock account statements, capital account
11 statements, tax returns, K-1s, bank ledgers, checkbook ledgers, or other bank account records, life
12 insurance policies, stock certificates, documents evidencing membership or other ownership
13 interest in any limited liability companies or other interest, any operating agreements for entities in
14 which STANDARD TRANSFER has any ownership interest, payment stubs, rent receipts,
15 documents showing interest in real estate, contracts, notes or memoranda evidencing indebtedness
16 due, deeds of trust, grant deeds, liens, claims, complaints, decrees, as well as any trust documents
17 evidencing a beneficiary interest in a trust. Documents provided should include the time period of
18 **January 1, 2008 to present;**

19 IT IS FURTHER ORDERED that the failure by STANDARD TRANSFER to appear at
20 the above ordered examination will subject it to contempt of Court;

21 IT IS FURTHER ORDERED that STANDARD TRANSFER is forbidden from making
22 any transfer of its non-exempt property and from interfering therewith until further ordered;
