15 This matter came before the Court on the *Receiver's Third Declaration and Report and*
16 *Motion for Authorization of Payment of Fees and Costs* (the "**Third Declaration and Report**").

17 In the Third Declaration and Report, Robert G. Wing, as the duly-appointed Receiver of the
18 corporate Defendants in this action, seeks entry of an order: (1) approving the Third Declaration
19 and Report; (2) authorizing payment from the receivership estate of \$17,786.10 to the Receiver
20 and Prince, Yeates & Geldzahler, for services rendered and costs incurred from January 1, 2010
21 through May 31, 2010; (3) authorizing payment from the receivership estate of \$51,633.65 to
22 PwC, for services rendered and costs incurred from January 1, 2010 through May 31, 2010; and,
23 (4) authorizing payment from the receivership estate of \$21,865.88 to RMA, for services
24 rendered and costs incurred from January 1, 2010 through May 31, 2010;.

25 Having reviewed the Third Declaration and Report and the invoices of Prince, Yeates &
26 Geldzahler, PricewaterhouseCoopers, and Rocky Mountain Advisory attached thereto,
27 determined that notice of the Third Declaration and Report and this proposed Order were timely
28 served on all parties to this proceeding and that the fees and costs of the Receiver, Prince Yeates

1 & Geldzahler, PricewaterhouseCoopers and Rocky Mountain Advisors were reasonably and
2 necessarily incurred for the benefit of the receivership estate, and for other good cause
3 appearing, it is hereby

4 ORDERED that:

5 A. The Third Declaration and Report is accepted and approved; and


6 B. Pursuant to section XX of the Court's *Preliminary Injunction With Asset Freeze,*
7 *Appointment of Receiver, and Other Equitable Relief* the Receiver may pay, from the liquid
8 assets of the Receivership Defendants or the receivership estate:

9 1. \$17,786.10 to the Receiver and Prince, Yeates & Geldzahler, for services
10 rendered and costs incurred from January 1, 2010 through May 31, 2010;

11 2. \$51,633.65 to PwC, for services rendered and costs incurred from January
12 1, 2010 through May 31, 2010; and,

13 3. \$21,865.88 to RMA, for services rendered and costs incurred from
14 January 1, 2010 through May 31, 2010.
