1       1. Since the last stipulation filed by the parties, Defendant JAMES HOWARD  
2       ("Defendant") and several representatives of the U.S. Forest Service have had a number  
3       of meetings at the site of the property involved in this case ("subject property"). During  
4       those meetings, those present discussed exactly what damages to the natural condition  
5       of the subject property had been caused by Defendant's alleged trespasses. Also  
6       discussed was the remedial steps the Forest Service believed needed to be taken in order  
7       to restore the subject property to its original, natural condition.

8       2. As a result of these meetings, Defendant has, during the last sixty (60) days, undertaken  
9       extensive reclamation work at and on the subject property, including hauling debris,  
10       rocks, and trash away; leveling portions of the ground; relocating a equipment housed  
11       on the subject property; and removing dead vegetation. The parties are pursuing those  
12       details presently and need about sixty (60) days to finalize the details and for Defendant  
13       to complete the remedial, corrective work.

14       4. Defendant's remedial work has been followed by the representatives of the Forest  
15       Service as the work has progressed and those representatives have given input,  
16       suggestions, and directions at various times during last sixty (60) days.

17       5. Most of the heavy, time consuming work has been completed, but additional time is  
18       needed to finalize and execute a plan of re-vegetation of the subject property. If all


