

3 Lien Claimant The A.C. Houston Lumber Company's Motion for Attorney's Fees,  
4 Costs and Interest, having been heard before the Court on August 26<sup>th</sup>, 2010 at the hour of  
5 10:30 a.m., THE A.C. HOUSTON LUMBER COMPANY being represented by Donald H.  
6 Williams, Esq. of The Law Offices of WILLIAMS & WIESE, AMTRUST BANK and IOTA  
7 INDIGO, LLC being represented by Mark A. Smith, Esq. of the law firm of SHIMON &  
8 SMITH, P.C., the Court having considered the Motion and the arguments of counsel and
