5 original document;

6 IT IS FURTHER ORDERED that Defendants American Home Mortgage Servicing,
7 Inc., Power Default Services, Inc., and Mortgage Electronic Registration Systems, Inc. shall
8 record a copy of this Order in the official records of Clark County, Nevada.
