STIPULATION AND ORDER

9 This Stipulation and Proposed Order relates to the hearings that are scheduled
10 for September 6, 2017 via the Court's Orders, ECF Nos. 275 and 276. The IOTA
11 Plaintiffs, Judgment Debtor Rex Lewis, and non-parties/proposed Intervenor
12 Woman Entities¹ hereby recite and request the following:

13 1. The IOTA Plaintiffs have filed a Renewed Motion for an Order Holding
14 Judgment Debtor Rex Lewis in Contempt (ECF No. 261), have filed a Renewed
15 Motion to Appoint a Receiver in Aid of Execution (ECF No. 265), and the Woman
16 Entities have filed a Motion to Intervene (ECF No. 270). All are fully briefed.

17 2. The Court has scheduled arguments on all of these matters, including an
18 evidentiary hearing, to take place on September 6, 2017 at 10 a.m.

19 3. In addition, the Court has ordered the IOTA Plaintiffs and Rex Lewis to
20 file a Joint Pre-hearing Order no later than August 30, 2017.

21 4. The Woman Entities and the IOTA Plaintiffs are in the process of
22 scheduling a mediation which is to take place on September 12, and/or 13, and if
23 those dates are not confirmed, no later than September 29, 2017.

24 5. As such, the parties to this Stipulation hereby request that the Court
25 reschedule all pending hearings scheduled for September 6, 2017 to a date after
26 September 29, 2017, and that the corresponding Joint Pre-hearing Order that comes
27 due on August 30, 2017 also be continued to 7 days before the continued hearing
28 takes place.

6. The parties to this Stipulation have negotiated its terms at arms' length and are seeking the Court's accommodation in good faith, and are not requesting the continuance for purposes of delay or frustration.
