21 Plaintiff, Righthaven LLC (“Righthaven”), by and through its attorneys of record, Tuff-
 22 N-Uff Productions, Inc. (“Tuff-N-Uff”) and Barry Meyer (“Mr. Meyer”); collectively with
 23 Righthaven and Tuff-N-Uff known herein as the parties (“Parties”), and pursuant to Rule
 24 41(a)(2) of the Federal Rules of Civil Procedure, hereby stipulate to a voluntary dismissal of all
 25 claims asserted against Tuff-N-Uff and Mr. Meyer, with prejudice, in the above-captioned


1 Specifically, Righthaven requests voluntary dismissal with prejudice pursuant to Rule
 2 41(a)(2) of the Federal Rules of Civil Procedure. Rule 41(a)(2) permits voluntary dismissal with
 3 prejudice "by court order, on terms that the court considers proper¹."

4 On or about September 7, 2010, the Parties entered into a settlement agreement (the
 5 "Agreement"), whereby Tuff-N-Uff and Mr. Meyer shall be released from all claims of
 6 copyright infringement in the above-entitled matter, upon full compliance with the terms of the
 7 Agreement.

8 WHEREFORE, the Parties request this Court enter an Order dismissing the above-
 9 captioned action filed against Tuff-N-Uff and Mr. Meyer with prejudice.


