**JOINT STIPULATION OF VOLUNTARY
 DISMISSAL WITH PREJUDICE**

20 Righthaven LLC (“Righthaven”), Bisig Impact Group, Inc. (“Bisig”), and Aaron Frisbee
 21 (“Mr. Frisbee”; collectively with Bisig known herein as the “Defendants”), by and through
 22 counsel of record, pursuant to Rule 41(a)(2) of the Federal Rules of Civil Procedure, hereby
 23 stipulate to a voluntary dismissal of all claims asserted against the Defendants, with prejudice, in
 24 the above-captioned matter.

25 On September 24, 2010, Righthaven and the Defendants entered into a settlement
 26 agreement (the “Agreement”), whereby the Defendants shall be released from all claims of
 27 copyright infringement in the above-entitled matter, upon full compliance with the terms of the
 28

1 Agreement. However, the Defendants require sixty (60) days from the effective date of the
2 settlement agreement to fully comply with the terms of the Agreement.

3 Therefore, Righthaven and the Defendants request this Court enter an Order dismissing
4 the above-captioned matter, and retain jurisdiction of the matter pursuant to the terms of the
5 settlement agreement.
