19 **JOINT STIPULATION OF VOLUNTARY  
DISMISSAL WITH PREJUDICE**

20 Plaintiff, Righthaven LLC (“Righthaven”), Off Shore Gaming Association (“OSGA”),  
21 and James Quigley (“Mr. Quigley”); collectively with Righthaven known herein as the  
22 “Parties”), by and through its attorneys of record and pursuant to Rule 41(a)(2) of the Federal  
23 Rules of Civil Procedure, hereby stipulate to a voluntary dismissal of all claims asserted against  
OSGA and Mr. Quigley, with prejudice, in the above-captioned matter.

24 Specifically, Righthaven requests a voluntary dismissal with prejudice pursuant to Rule  
25 41(a)(2) of the Federal Rules of Civil Procedure. Rule 41(a)(2) permits voluntary dismissal with  
26 prejudice “by court order, on terms that the court considers proper<sup>1</sup>. ”


