25 **JUDGMENT**

26 **FINAL JUDGMENT AS TO DEFENDANTS DOUGLAS A. GLASER, APHENOS**  
 27 **CAPITAL, INC, and ADVIDEA, INC.**

28 Pursuant Federal Rules of Civil Procedure 55, this court hereby grants the motion for  
 default judgment brought by plaintiff, WORDLOGIC CORPORATION (“WORDLOGIC”),  
 against defendants DOUGLAS A. GLASER (“GLASER”); APHENOS CAPITAL, INC.; and  
 ADVIDEA, INC. (collectively referred to as “Defendants”) based on their failure to “plead or  
 otherwise defend” and enters the following judgment:

2 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** that plaintiff,  
3 WORDLOGIC CORPORATION is the prevailing party to this lawsuit.

5 **IT IS HEREBY FURTHER ORDERED, ADJUDGED, AND DECREED** that  
6 Defendants their employees, agents, and persons acting with them or on their behalf shall be  
7 subject to the following:

9 a. Defendants and their employees, agents, and persons acting with them or on their  
10 behalf, are hereby restrained and enjoined from selling, transferring or encumbering  
11 WORDLOGIC stock issued to Defendants pursuant to certificate numbers 4005, 4006, 4008,  
12 4009, and 4010.

13  
14 b. Defendants and their employees, agents, and persons acting with them or on their  
15 behalf are hereby ordered to return to WORDLOGIC all WORDLOGIC stock issued to  
16 Defendants pursuant to certificate numbers 4005, 4006, 4008, 4009, and 4010.

17  
18 c. Defendants and their employees, agents, and persons acting with them or on their  
19 behalf are hereby ordered to turn over any proprietary information including usernames and  
20 passwords necessary to control WORDLOGIC's website (wordlogicurl.com) and "800 number"  
21 (1-888-742-5054) associated with the website.



23 d. Defendants and their employees, agents, and persons acting with them or on their  
24 behalf are hereby ordered to stop removing proceeds earned from the sale of WORDLOGIC  
25 products on the website and "800 number" associated with the website.

1 e. Defendants and their employees, agents, and persons acting with them or on their  
2 behalf are hereby ordered to return any proceeds from the website and "800 number" associated  
3 with the website.

5 f. Defendants and their employees, agents, and persons acting with them or on their  
6 behalf are hereby ordered to relinquish to WORDLOGIC all analog or digital footage resulting  
7 from the filming of the infomercial.
