19 JUDGMENT BY DEFAULT AGAINST JAMES WENZL

20 Defendant JAMES WENZL, having been served with the Summons and Complaint, and  
21 having failed to appear, plead, answer, or otherwise defend as to the Complaint of Plaintiffs,  
22 MASSACHUSETTS MUTUAL INSURANCE COMPANY and MML INVESTORS  
23 SERVICES, INC., the legal time having expired and not having been extended; it appearing that  
24 said Defendant, JAMES WENZL, is not in the military service of the United States, is not a  
25 minor, and is not an incompetent person; and the default of Defendant, JAMES WENZL, having  
26 been duly entered according to law; upon an application of Plaintiffs, MASSACHUSETTS  
27 MUTUAL INSURANCE COMPANY and MML INVESTORS SERVICES, INC., judgment is

1 hereby entered against Defendant, JAMES WENZL, in accordance with the prayer of the  
2 Complaint and good cause appearing therefore:

3 IT IS ORDERED, ADJUDGED, and DECREED, that Plaintiffs, MASSACHUSETTS  
4 MUTUAL INSURANCE COMPANY and MML INVESTORS SERVICES, INC., recover of  
5 and from Defendant, JAMES WENZL, as follows:

7 1. The principal sum of FORTY FIVE THOUSAND DOLLARS (\$45,000) for the  
8 improper withdrawal/unpaid amount(s) from MassMutual's Agency Operations Account,  
9 Nevada State Bank Account No. xxxxxx807;

10 2. The principal sum of NINETEEN THOUSAND FIVE HUNDRED SEVENTY-  
11 SIX DOLLARS (\$19,576.00) for the improper withdrawal/unpaid amount(s) from MassMutual's  
12 Agency Housing Account, Nevada State Bank Account No. xxxxxx831;

13 3. Interest on the principal amounts, set forth in paragraphs 1 and 2, at the legal rate  
14 from the date of this judgment until paid in full, which equals \$9.29 per day;

15 4. Pre-judgment interest at the legal rate on the unpaid balances from the date the  
16 Summons and Complaint was served until the date of this judgment; up to August 24, 2011, the  
17 pre-judgment interest that has accrued is \$3,121.44 and an additional \$9.29 will accrue each  
18 additional day until judgment is entered<sup>1</sup>; and


