WILLIAMS, et al., 14 15 Respondents. 16 17 This is a petition for writ of habeas corpus pursuant to 28 U.S.C. § 2254 in which 18 petitioner, a state prisoner, is proceeding with counsel. Petitioner has paid the filing fee for this 19 action. (ECF No. 1). The petition shall now be served on respondents. 20 A petition for federal habeas corpus should include all claims for relief of which 21 petitioner is aware. If petitioner fails to include such a claim in his petition, he may be forever 22 barred from seeking federal habeas relief upon that claim. See 28 U.S.C. §2254(b) (successive 23 petitions). If petitioner is aware of any claim not included in his petition, he should notify the Court 24 of that as soon as possible, perhaps by means of a motion to amend his petition to add the claim. 25 IT IS THEREFORE ORDERED that the clerk shall ELECTRONICALLY 26 **SERVE** the petition (ECF No. 1) upon respondents.

IT IS FURTHER ORDERED that respondents shall have forty-five (45) days from entry of this order within which to answer, or otherwise respond to, the petition. In their answer or other response, respondents shall address any claims presented by petitioner in his petition as well as any claims presented by petitioner in any statement of additional claims. Respondents shall raise all potential affirmative defenses in the initial responsive pleading, including lack of exhaustion and procedural default. Successive motions to dismiss will not be entertained. If an answer is filed, respondents shall comply with the requirements of Rule 5 of the Rules Governing Proceedings in the United States District Courts under 28 U.S.C. §2254. If an answer is filed, petitioner shall have forty-five (45) days from the date of service of the answer to file a reply.

IT IS FURTHER ORDERED that, henceforth, petitioner shall serve upon the attorney gGeneral of the State of Nevada a copy of every pleading, motion, or other document he submits for consideration by the court. Petitioner shall include with the original paper submitted for filing a certificate stating the date that a true and correct copy of the document was mailed to the attorney general. The court may disregard any paper that does not include a certificate of service. After respondents appear in this action, petitioner shall make such service upon the particular deputy attorney general assigned to the case.
