ORDER EXPUNGING LIS PENDENS

19 This Court issued an Order [Doc #39] Granting Aurora Loans Services, LLC and Mortgage
20 Electronic Registration Systems, Inc. (collectively, "Defendants") Motion to Dismiss [Dkt. 6]. The
21 Plaintiff's state law claims were dismissed without prejudice. [Doc #6 at 1:14-15]. The Plaintiff's
22 federal claims under The Truth in Lending Act and The Real Estate Settlement Procedures Act were
23 dismissed with leave to amend; however, Plaintiff was required to file his amended complaint by
24 August 29, 2011; however, he has failed to do so. [Doc #40].

25 Defendants request that the lis pendens Plaintiff JAMES BRADLEY BAILEY ("Plaintiff")
26 recorded against the subject property be canceled.

27 The Court finds that Plaintiff recorded a Notice of Lis Pendens ("Lis Pendens") on or about
28 December 7, 2010, as Instrument Number 201012070003736 in real property records maintained by

1 the Clark County Recorder. A copy of the Lis Pendens is attached hereto as **Exhibit A** and fully
2 incorporated by reference.


3 Upon consideration of Defendants' request to cancel the above-referenced Lis Pendens, and
4 good cause appearing therefore, the Court hereby grants Defendants their requested relief and rules
5 as follows:

6 1. It is ordered, adjudged and decreed that the above-referenced Lis Pendens is hereby
7 canceled, released and expunged.

8 2. It is further ordered, adjudged and decreed that this Order canceling the above-
9 referenced Lis Pendens has the same effect as an expungement of the original Lis Pendens.

10 3. It is further ordered, adjudged and decreed that Defendants record a properly certified
11 copy of this Cancellation Order in the real property records of Clark County, Nevada within a
12 reasonable amount of time from the date of this Order's issue.
