days after the first day of publication on the United States's official internet forfeiture site, 1 2 www.forfeiture.gov;

3 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the person asserting 4 such interest in property must serve and must file an answer to the United States's Complaint for 5 Forfeiture In Rem or a motion under Rule 12 no later than 21 days after filing the claim, pursuant to Fed. R. Civ. P. Supp. Rule G(5)(b); 6

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the claim and the 7 8 answer must be served on Michael A. Humphreys, Assistant United States Attorney, United States 9 Attorney's Office for the District of Nevada, 333 Las Vegas Blvd. South, Suite 5000, Las Vegas, Nevada 89101, at the times of filing, pursuant to Fed. R. Civ. P. Supp. Rule G(5)(a) and (b). 10

Failure to file a verified claim and an answer within the prescribed times shall result in a 11 judgment of forfeiture by default. 12

13 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that notice of the action and the arrest be given by the United States of America on the United States's official internet 14 15 forfeiture site, www.forfeiture.gov, for at least 30 consecutive days pursuant to Fed. R. Civ. P. Supp. Rule G(4)(a)(iv); 16

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that a copy of the 18 Complaint for Forfeiture In Rem, this Order, the Summons and Warrant of Arrest in Rem for the Property, and the Notice of Complaint for Forfeiture and Arrest of Property be personally served, or 19 if unable to effect personal service, sent by certified mail, return receipt requested, and regular mail, 20 to all persons claiming an interest in the property. 21
