In its preliminary injunction order, the Court ordered Johnson to repatriate assets 16 located outside the United States, and turn them over to the Receiver. (See Section IX). The 17 Court further ordered Johnson, as well as other persons with notice of the preliminary injunction, 18 to turn over receivership assets to the Receiver. (Section XVI). Finally, the Court ordered 19 Johnson and others with notice of the preliminary injunction to cooperate with the Receiver in its 20 administration of the receivership estate. (Section XVII). The Court orders Johnson, and others 21 previously referred to in this order, to comply with these provisions of the preliminary injunction 22 by turning over possession of the foregoing to the Receiver or its representative, as requested by 23 the Receiver. 24
