14 **ORDER FOR SUMMONS AND WARRANT OF ARREST**
15 **IN REM FOR THE PROPERTY AND NOTICE**

16 A Complaint for Forfeiture in Rem arising from a federal statute has been filed by the United
17 States of America, pursuant to Fed. R. Civ. P. Supp. Rule G. The Court, having reviewed the
18 Complaint, has found probable cause and that the United States has possession of the defendant
19 property; therefore, the clerk shall issue a Summons and Warrant of Arrest in Rem for the Property,
20 pursuant to Fed. R. Civ. P. Supp. Rule G(3)(b).

21 **IT IS HEREBY ORDERED, ADJUDGED, AND DECREED** that a Summons and Warrant
22 of Arrest in Rem for the Property issue against the property.

23 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the United States of
24 America seizes, arrests, takes into custody, and retains the 2010 Nissan 370Z, VIN number
25 JN1AZ4FH1AM301985 .

1 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that all persons claiming
2 an interest in the property must file a verified claim, pursuant to Fed. R. Civ. P. Supp. Rule
3 G(4)(b)(ii)(B) and (5)(a)(ii)(A) and (B), no later than 35 days after the notice is sent or, if direct notice
4 was not sent, no later than 60 days after the first day of publication on the United States's official
5 internet forfeiture site, www.forfeiture.gov.

6 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the person asserting
7 such interest in property must serve and must file an answer to the United States's complaint for
8 forfeiture in rem or a motion under Rule 12 within 21 days after filing the claim, pursuant to Fed. R.
9 Civ. P. Supp. Rule G(5)(b).

10 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the claim and the
11 answer must be served on Michael A. Humphreys, Assistant United States Attorney, United States
12 Attorney's Office for the District of Nevada, at 333 Las Vegas Blvd., South, Suite 5000, Las Vegas,
13 Nevada 89101, at the times of filing, pursuant to Fed. R. Civ. P. Supp. Rule G(4)(a)(ii)(C) and
14 (b)(ii)(D) and (5)(a)(i)(D) and (b).


15 Failure to file a verified claim and an answer within the prescribed times shall result in a
16 judgment of forfeiture by default.

17 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that notice of the action
18 and the arrest be given by the United States of America on the United States's official internet
19 forfeiture site, www.forfeiture.gov, for at least 30 consecutive days pursuant to Fed. R. Civ. P. Supp.
20 Rule G(4)(a)(iii)(B) and (iv)(C).

21 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that a copy of the
22 Complaint for Forfeiture In Rem, this Order, the Summons and Warrant of Arrest in Rem for the
23 Property, and the Notice of Complaint for Forfeiture and Arrest of Property be personally served, or
24 if unable to effect personal service, sent by certified mail, return receipt requested, and regular mail,
25 to any person who reasonably appears to be a potential claimant pursuant to Fed. R. Civ. P. Supp. Rule
26 G(4)(b)(i).

1 **IT IS FURTHER ORDERED, ADJUDGED, AND DECREED** that the United States of
2 America shall file proof of publication and service with the Clerk of this Court.
