STIPULATED JUDGMENT

COMES NOW, Plaintiff, XEROX CORPORATION (hereinafter "Plaintiff"), by and through its attorneys of record, the Law Office of Hayes & Welsh, and Defendants, HAIG'S QUALITY PRINTING-NEVADA, INC. and HAIG GARABED ATAMIAN (hereinafter "Defendants"), by and through their attorney of record, George E. Cromer, Esq., and hereby stipulate to a judgment as follows:

IT IS HEREBY STIPULATED that Judgment shall be entered in favor of Plaintiff and against Defendants in the principal amount of ONE HUNDRED EIGHTY SIX THOUSAND AND 00/100 DOLLARS (\$186,000.00), plus interest at the legal rate from the

1 date of entry of this Judgment until paid in full. Each party shall bear responsibility for
2 payment of their own pre-judgment costs and attorneys' fees.

3 IT IS HEREBY STIPULATED that Defendants agree to make payments to Plaintiff
4 as follows:

- 6 **a) Payments in the amount of \$3,000.00 per month due on May 10, 2011, June 10, 2011, July 10, 2011, August 10, 2011, September 10, 2011 and October 10, 2011.**

 - 8 **b) Payments in the amount of \$4,000.00 per month beginning on November 10, 2011 and due on the 10th day of each month thereafter until the Settlement Amount is paid in full.**

10 Defendants' payments referenced herein shall be made in United States dollars in the
11 form of a business check and/or certified funds. All payments shall be made payable to
12 Xerox Corporation and include the reference number 957255490 and shall be delivered to
13 Xerox Corporation, 88188 Expedite Way, Chicago, IL 60695-0001.

14 Plaintiff shall allow Defendants a grace period of seven (7) days on all payments. If
15 Defendants fail to make payment as outlined above within seven (7) days of the due date,
16 Defendants shall be in default under this Stipulated Judgment. Plaintiff is under no
17 obligation to give Defendants notice of a default and may take immediate legal action under
18 the Stipulated Judgment and/or Mutual Release and Settlement Agreement (incorporated
19 herein by reference) entered into between the parties.

21 IT IS HEREBY STIPULATED that Plaintiff shall not record or execute upon this
22 judgment unless Defendants fail to perform any of the terms and conditions of this Stipulated
23 Judgment.

25 IT IS HEREBY STIPULATED that Plaintiff shall be entitled to an award of any
26 attorneys' fees or costs incurred in enforcing and/or executing upon this Stipulated Judgment.

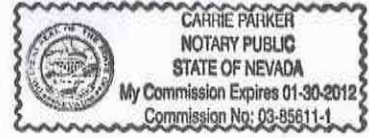
